We are writing to you because you have been identified as a consultee under section 42(1)(d) of the Planning Act 2008, as you own, occupy or have a legal interest in land which AQUIND has identified as being potentially affected by the proposals for AQUIND Interconnector.

You may have heard from us previously because we have identified and contacted you as a person who may have an interest in the land potentially affected by the proposals for AQUIND Interconnector, by virtue of a registered or assumed ownership of the subsoil beneath the highway abutting your property. This is because much of the underground cable for AQUIND Interconnector is proposed to be located beneath the highway, and there is a legal assumption that where no owner of a highway is registered at the Land Registry or otherwise identifiable, the adjoining landowner owns the subsoil of the highway up to the middle of the road.

**It is not intended that the underground cable for AQUIND Interconnector will be laid within the boundary of any homes or gardens along the proposed cable route. As such, it is not anticipated that any land comprised in or rights over any homes or gardens will be required in connection with AQUIND Interconnector.**
