Dear Stakeholder,

I am writing to inform you about the AQUIND Interconnector project. We are contacting all stakeholders who have a recreational angling interest within the Solent and surrounding area as this project will be taking place within this area.

The AQUIND Interconnector is a national significant infrastructure project that proposes to enable the transfer of electricity from the UK to France and vice versa.

The planned route for the project is from Eastney, Portsmouth (UK) to Pourville, Normandy (France). AQUIND Interconnector - Consultation Newsletter

We'd like to hear from you

AQUIND Limited ("AQUIND") is developing proposals to build and operate AQUIND Interconnector – a new marine and underground electricity transmission link between the south coast of England and Normandy in France.

Following an initial round of consultation in January 2018, AQUIND will be undertaking consultation on its proposals for

AQUIND Interconnector between **Wednesday 27 February 2019** and **Monday 29 April 2019**.

The purpose of this consultation is to seek informed feedback on the proposal which may be taken into account as it is further developed prior to the submission of an application for a Development Consent Order that would seek the permissions and powers required to build and operate AQUIND Interconnector in the UK.

1 About AQUIND Interconnector

AQUIND is proposing to construct and operate an electricity interconnector between the south coast of England (Lovedean, Waterlooville with landfall at Eastney, Portsmouth) and Normandy in France, to be known as AQUIND Interconnector.

AQUIND Interconnector will have capacity to transmit up to 16 000 000 MWh of electricity or approximately 5% of Great Britain's total electricity consumption – enough to keep the lights on in up to 4 million British households. It will make a significant contribution to improving Great Britain's security and flexibility of electricity supply and achieving greater affordability by improving competition, making Great Britain's energy market more efficient.¹

AQUIND intends to submit an application for a Development Consent Order (DCO) to grant the rights required to build and operate AQUIND Interconnector in the UK to the Planning Inspectorate (PINS), who will examine the application in public before making a recommendation to the Secretary of State who will make the final decision, taking into account the local impacts of the proposal.

2 Scope of the consultation

This consultation relates only to the elements of AQUIND Interconnector which would be located in England and in the sea adjacent to England.

As part of the consultation, AQUIND will present the proposed extent of the project's geographical boundary (onshore and marine), including information on cable installation methods, the landing point location, the proposed underground cable

route options currently under consideration and the converter station location including indicative building designs, along with initial landscape mitigation.

AQUIND anticipates an application for a DCO for the project will be submitted in late 2019, following this consultation exercise having been undertaken and the proposal has been further refined having regard to the feedback received.

3 Accessing the consultation documents

The consultation documents are available to view and download on the consultation website at www.aquindconsultation.co.uk and are comprised of the following:

- Consultation Document, providing a detailed explanation of the proposals and the key issues to be considered during the consultation;
- Preliminary Environmental Information Report (PEIR) and Technical Appendices;

During the consultation, AQUIND will be holding public exhibition events in Portsmouth, Havant, East Hampshire and Winchester, the details of which are set out in section 4. The exhibitions will provide an opportunity to view the consultation documents and discuss the proposals with members of the AQUIND project team.

The consultation documents are also available to view during the consultation at various deposit locations in the vicinity of the proposals the details of which are set out in section 5.
