## INTRODUCTION

### AQUIND Interconnector - Compulsory Acquisition Status Report

This document has been prepared to provide the status of negotiations and agreements for permanent or temporary rights required for the Proposed Development as at Deadline 1 as requested by the ExA pursuant to the Rule 6 letter issued on 3 July 2020.

**Heads of terms in Negotiation-** The Applicant has issued an offer of terms for a Voluntary Agreement and is engaged in active negotiations with the landowner or their representatives

**Legal Drafting in Progress-** Terms of a Voluntary agreement are agreed in principle, Solicitors are instructed and the legal agreement is being finalised

**Option Agreement signed-** The legal agreement has been exchanged and completed

**PP in negotiation-** The Applicant is negotiating Protective Provisions with the relevant stakeholder.

**SOCG in negotiation-** The Applicant has issued a Statement of Common Ground which is being discussed with the affected party

The Status Report does not include any subsoil interests beneath the land which forms the highway. These parties are identified in the Book of Reference (APP-022) and have been consulted as per the requirements of s.42 and s.56 of the Planning Act 2008. Further information in relation to the approach to be taken to acquiring subsoil interests is provided in the Statement in relation to approach to acquisition of subsoil beneath the highway associated with AQUIND Interconnector (Document Reference 7.7.2).
