1. INTRODUCTION

1.1. OVERVIEW

- 1.1.1.1. An Application (the 'Application') for a Development Consent Order ('DCO') for the UK elements of AQUIND Interconnector (the 'Proposed Development') was made by AQUIND Limited (the 'Applicant') to the Secretary of State ('SoS') for Business, Energy and Industrial Strategy ('BEIS') on 14 November 2019. The Proposed Development is described in Chapter 3 (Description of the Proposed Development) of the Environmental Statement ('ES') (APP-118).
- 1.1.1.2. The Application was accepted for Examination on 12 December 2019, with a Preliminary Hearing scheduled for 22 April 2020. Due to Coronavirus (COVID-19) the Examining Authority ('ExA') issued a Procedural Decision on 2 April 2020 to postpone the Examination. On 3 July 2020, the ExA issued a new letter under Rule 6 of The Infrastructure Planning (Examination Procedure) Rules 2010 with a revised timetable with the Examination commencing on 18 August 2020.

1.2. PURPOSE OF THIS DOCUMENT

- 1.2.1.1. This document contains the Schedule of Changes in relation to changes made to documents previously submitted with the Application, as set out within the tables below.
