INTRODUCTION

AQUIND Interconnector - Compulsory Acquisition Status Report

Option Agreement signed- The legal agreement has been exchanged and completed

PP in negotiation- The Applicant is negotiating Protective Provisions with the relevant stakeholder.

SOCG in negotiation- The Applicant has issued a Statement of Common Ground which is being discussed with the affected party

The Status Report does not include any subsoil interests beneath the land which forms the highway.
