Thank you for your submission regarding the AQUIND interconnector Development Consent Order (DCO) application.

Whilst it does not appear that you previously registered as an Interested Party, and the deadline for which has passed, the Examining Authority has agreed, on this occasion, to exercise its discretion to accept your correspondence into the Examination as a Deadline 1 submission, considering it to be information that may be relevant to its recommendation to the Secretary of State. All such submissions

received by 12 October 2020 have been accepted. The Examining Authority is unlikely to accept submissions from people who have not registered as Interested Persons after this date.

The Examining Authority will also request the Applicant, in due course, to respond to the main issues raised by the submissions that have been accepted. This response will also be published on the project page of the Planning Inspectorate's National Infrastructure website.

While the period for registering to become an Interested Party has closed, you can follow the progress of the Examination on the project website, where you will also find links to recordings of the Preliminary Meeting and links to any livestreams of future Hearings.

Local authorities whose area may be affected by the Proposed Development will be represented throughout the Examination, and each recently submitted a Local Impact Report to the Examining Authority. A Local Impact Report details the likely effects of the proposed development on the authority's area and residents. The Reports can be accessed through the Examination Library, which can be found in the 'documents' tab on the project page of the Planning Inspectorate's National Infrastructure website.
