Hello,

I understand that I am able to provide bullet points only for detail of what I will be saying next Monday at the hearing which I provide below.

Therefore, I will be talking about the following issues:

- 1. The disruption caused by horizontal drilling to Southsea Leisure Park and beach users (and potentially any construction work at Fraser Range) while it is taking place to bring the cable ashore.
- 2. The lack of clarity as to whether the drilling will originate on dry land or under the sea and the lack of detail as to what the drilling rig will look like and the impact it will have on the local environment (including the extracted material).
- 3. The impact of a majority of the car park being taken out of action at Fort Cumberland Road for the duration of the construction of the cable.
- 4. The lack of possible mitigation for both the occupation of the car park during the construction and permanent loss of part of the car park in perpetuity due to structures being constructed.
- 5. The detrimental impact of the construction of structures in Fort Cumberland Road car park.
- 6. The severe impact of the disruption of the Henderson Road/Ferry Road/Fort Cumberland Road junction on amenity to the whole of the area of Eastney to the east of this point, including public transport and emergency services access, general ingress/egress for residents and the Sense Plus learning disability day service adjacent to the junction.

Could I also ask if you could confirm what time you will be calling me to speak next Monday.
