And at the time, there was great concern, in part due to the nature of the land interest questionnaire that had been put out, which had, unfortunately given the impression to very large numbers of people in the city that they may have their homes compulsorily purchased. More recently, there have been issues around the concerns about allotments being built over or having access and disrupting allotments. And although both of those issues are no longer live issues, what they have done is create an atmosphere of deep concern and mistrust. That what people think is going to come to pass, may not. And I would just ask people to bear that in mind for future communications. But also when this is being assessed, turning to matters, which are an issue in our lives. As I say I've had an enormous number of representations from my constituents. They cover a broad range of issues, including some touching on health issues, but largely they fall into two categories. Firstly, environmental and ecological. And this is a huge concern to my constituents, we have been incredibly active in all sorts of issues concerned with the harbour in particular, the seabed, the health of the seabed, species, water quality, many other related issues. And there's a huge amount of concern about this development on that. And then secondly, although I note the new proposed routes, still outstanding issues around traffic disruption, particularly from zetland Park onwards. And this is, I think, a grave concern to both my constituents, but also surrounding areas. What I would say is that whatever the merits of this project in terms of national infrastructure, if you were going to pick a point on the south coast, to provide that connection, it would not be Portsmouth. We are the most densely populated city in Europe outside of London. We have incredible stresses on our transport network. We have vital concurrent

development going on during the course of this project. And I can't emphasise enough how strongly my constituents object to this taking place. And I would hope that the concerns of Portsmouth city council and other local authorities are taken on board, although noting the process that we are locked into. So thank you for the opportunity to get that on the record.

We watch the barn owls deers, buzzard, woodpeckers, patches, pheasant, rabbits and foxes along with a large variety of other birds. The peace and quiet here has and still is

It has rows of narrow streets shown that cause air pollution and back to back terrorist housing. Because of this, Portsmouth residents need access to open space. The proposed interconnector route will have a devastating impact on access to one of the early two large green community spaces Portsmouth has the interlink nature reserves of farlington marshes links to harbour and Milton common. These areas

are much left not only for the beauty, but because they provide much needed respite from heavy urbanisation and are regularly used by hundreds of people in the city so developed, this green space is priceless and irreplaceable. The alternate the screen space to tackle obesity, and government objective introduced in July 2020. And the particular problem in Portsmouth about over a guarter starting primary school are bigger than the national benchmark. This green space is also vital to protecting the city's mental health crisis. over a quarter of Portsmouth people experience a mental health problem each year. But Portsmouth suicide rate has been seven times higher than South East average. local mental health services old stress the importance of looking after mental and physical health through exercise. Being able to do so for free away from busy air polluted streets is vital to the city's mental and physical health. The proposed route will bring further health risk to Portsmouth people in the form of dangerous level of nitrogen dioxide due to an increase in congestion. You need to live in Portsmouth to truly understand how bad the traffic issues already are, and how little it takes to disrupt its flow. Traffic Flow is so delicately balanced that if it rains or a set of traffic light goes down. It has a huge knock on effect across the entire island and traffic grinds to hold. Even without any incidences, traffic is often at standstill daily as one of the only three main arterial routes onto and off an island serving a population density greater than London. Any walks along Easton route will cause gridlock and untold stress and misery to all Portsmouth inhabitants, businesses and visitors not just those along its immediate route. Traffic Management measures along Eastern route during the accident works will lead to gueuing traffic in this location. This will have a detrimental impact on air pollution concentrations at the knee exceedance location along Easton road pushing the site into exceedance traffic delays along Eastern roadway resides and traffic rerouting by a London route Eisley m 275 or a 2020 all of which are already an exceedance. Making air quality in these areas is more toxic. Portsmouth air quality levels caused by congestions are already so dangerous. They're illegal. This clean air objective cannot be met if the internet Connect interconnect cables given the go ahead on its current route, as it will exacerbate existing air quality and congestion issues not only in the immediate area five across the whole island of Portsmouth. This gridlock also risk delays for central workers trying to get to St. Mary's and QA hospital, as well as ambulances in Texas with resulting impacts on emergency patient care and discharge time and disruption. Also, it's impacting GPS ability to conduct timely patient home visits and thus availability of general appointments. This gridlock will also discourage business investment and visitors. Putting a city already struggling with poverty nearly a quarter of children in some Portsmouth wards are living in poverty and to further economic decline and risking jobs.
