*m) Continuous or periodic exposure to noise*

*In relation to ExQ1 N1.11.5, the Applicant has provided further explanation at paragraph 17.3.2.3 of the ES addendum [REP1-139] to explain how successive periods of noise have been treated in the noise assessment. Havant Borough Council and East Hampshire District Council have expressed concern about the methodology. Does this update satisfy these concerns and is there now common ground between the parties on this matter?*

I can confirm that the update does satisfy my concerns and this is now a matter of common ground between the parties concerned.

To clarify further regarding my attendance, it had already been agreed, following discussions between ourselves, that Winchester's Phil Tidridge would respond to other matters which were relevant for both our Authorities, to avoid us offering duplicate opinions on the same issues.

I have today had a meeting with Winchester City Council and Hampshire Highways Authority regarding the issue of hours of work for construction works, some of which will take place in Havant Borough Council's area.
