Prime Minister and Deputy Prime Minister,

I write to you on behalf of all members of the Portsmouth City Council Conservative Group regarding the AQUIND Interconnector Scheme proposal.

This week the Secretary of State for Business, Energy and Industrial Strategy, The Rt Hon. Kwasi Kwarteng is about to make the decision on the scheme. Given the allegations that have come to light over recent weeks, including the Pandora Papers, how can the Secretary of State credibly take this decision? He is compromised in our group's opinion.

As you will be aware, previous ministers who have received donations from AQUIND have had to recuse themselves from decision-making roles. We feel that Mr Kwarteng is compromised, especially given his correspondence and handwritten notes dated October 2019 to AQUIND that have been uncovered.

The interconnector scheme is not wanted here in Portsmouth where, if permission is given, it will cause havoc and misery to local people. With only three roads on and off of Portsea Island, the planned route for the interconnector cable up the Eastern Road (A2030) will have a knock-on effect on congestion, air pollution and peoples day-to-day lives. That is unacceptable when over the past few years many of us and campaigners have suggested better alternative routes for the interconnector that would see it miss Portsmouth entirely and still reach its destination in Lovedean, Havant. Given your own environmental credentials and desires that many of my group share, this scheme, in our opinion is incompatible with our own green and environmental agenda.

Here in Portsmouth and neighbouring constituencies, AQUIND has successfully united all political parties against its scheme. Quite something for an urban political hot-spot like Portsmouth.

The further impacts on the city are well documented and well made by others who have written to you and other ministers, including Penny Mordaunt MP.


