Superseded Documents

As noted above, documents have been updated to reflect the minor errors and omissions highlighted in the Section 51 advice and the request to submit updated plans and documents. An explanation is provided in respect of the following documents and plans to provide further explanation on the updates undertaken.

• Land Plans – Following receipt of the Section 51 advice a review of the Land Plans was undertaken to cross-check with the plot descriptions used in the Book of Reference. The Land Plans have been updated to include additional annotations in respect of public roads, tracks, towns, villages or rivers names where necessary. However, we have not sought to include individual property names on the Land Plans if they are not already included on the OS base mapping. In our view it is not appropriate or necessary to identify individually named properties on the Land Plans other than those already included on the OS base mapping. Please note we have also not manipulated the OS base mapping to simplify or remove identifiers already included on the OS base mapping as this is not National Grid data.

- Access Rights of Way and Public Rights of Navigation Plans as advised, a
 consistency check was undertaken of the Access Rights of Way and Public Rights of
 Navigation Plans and the schedules of the draft DCO. Please note this has resulted
 in updates to the schedules of the draft DCO only, as can be seen in the superseded
 DCO (Document 3.1(B)); no update was required to the Plans and therefore these
 have not been submitted.
- The Explanatory Memorandum and No Significant Effects Reports have been updated to address the consistency and formatting errors identified.

Separate to the Section 51 advice the following superseded documents have also been provided due to formatting errors identified by the Applicant and to split out confidential information from the Extended Phase 1 Habitat Survey Report.

- Document 5.3.8B(B) Appendix 8B Extended Phase 1 Habitat Survey Report.
