Points to Note

The following section of this cover letter confirms National Grid's position in respect of items that the ExA requested to be submitted at Deadline 5 as per the Examination Timetable in the Rule 8 letter (dated 29 March 2023) and any other points to note in respect of Deadline 5.

Applicant's updated Compulsory Acquisition, Temporary Possession and Statutory Undertakers Schedules of Negotiations, Powers Sought and Objections.

National Grid has sought to update all Compulsory Acquisition, Temporary Possession and Statutory Undertakers Schedules of Negotiations, Powers Sought and Objections as requested by the Examination Timetable. Please note that no update to **Statement of Reasons Appendix A: Details of Purpose for Which Compulsory Acquisition and Temporary Possession Powers are Sought (Document 4.1-A(B))** has been submitted as there are no updates in respect of the information provided in this document.

An updated Protective Provisions Progress Schedule (**Document 8.12(C)**) has been submitted at Deadline 5, which sets out the status of protective provision negotiations with statutory undertakers. Section 127 and Section 138 Statements have also been submitted at Deadline 5 for any protective provisions not yet agreed with relevant statutory undertakers as follows:

- Network Rail Infrastructure Limited (Document 8.27.1);
- National Highways (Document 8.27.2);
- National Gas Transmission (Document 8.27.3); and
- Northern Gas Networks (Document 8.27.4).

Updated statements of common ground with statutory undertakers where agreement is outstanding have been submitted at Deadline 5. Notwithstanding the submissions made at this deadline, engagement is continuing with a view to reaching agreement with each statutory undertaker before the close of the examination.

Important Hedgerow Survey Updates

Since the submission of ES Chapter 8 Appendix 8B - Extended Phase 1 Habitat Survey Report (**Document 5.3.8B(C)**), [**REP2-027**] and Figure 8.6 Important Hedgerows, ES Chapter 8 Biodiversity Figures Part 1 and 2 (**Document 5.4.8(B)**, [**REP2-033**, **REP2-034**]) at Deadline 2 additional surveys have been undertaken for both the two unsurveyed potentially important hedgerows (HE103 and HE045). The survey has concluded that both hedgerow HE103 and HE045 are not important in accordance with the wildlife and landscape criteria set out in The Hedgerow Regulations 1997. An additional hedgerow has been identified in the vicinity of Monk Fryston Substation (HE106) which was omitted from the previous report and figure and is now included. This hedgerow has been assessed as important based on the historic environment criteria set out in the Hedgerow Regulations 1997.

Statement of Common Ground between National Grid and Historic England

National Grid has relayed the ExA's clear request for this SoCG to be signed with Historic England. Following further discussion, Historic England has confirmed that due to their extensive workload and the number of NSIP schemes they are being requested to engage on, they are having to identify which projects they need to engage on, and which projects they are not concerned with. Historic England has confirmed that Yorkshire GREEN is a Project they do not have concerns with, following early engagement, and their legal team have therefore instructed that they should not enter into a SoCG.

In light of this discussion, Historic England emailed the Planning Inspectorate on 6 July 2023 further confirming their satisfaction with the Project. National Grid has submitted the SoCG setting out correspondence and agreed matters (**Document 8.5.8(B)**). Noting the points above, National Grid considers this to be an agreed, but unsigned SoCG.
