National Grid Electricity Transmission plc (National Grid) – The National Grid Yorkshire Green Energy Enablement (GREEN) Project – EN020024

Application for changes to a Development Consent Order (DCO) Application

National Grid notified the Examining Authority (ExA) of its intention to submit a request for proposed changes to the DCO Application in our letter of 19 June [AS-020]. The ExA issued a procedural decision in respect of this notification on 22 June 2023 [PD-012]. National Grid issued a letter to the ExA on 26 June 2023 providing clarification on its intended approach to the submission of supporting documentation with the request for proposed changes [AS-021].

Further to the above, National Grid hereby submits a request for the following changes to the Scheme (the Proposed Changes) to be accepted for examination:

- Change 1 Shipton North Reduction in Limits of Deviation (within Work No.2).
- Change 2 New Farm Cottage Access (within Work No. 5).
- Change 3 Shipton Cable Sealing End Compound (CSEC) Access (within Work No.2).

National Grid's notification [AS-020] identified four proposed changes. National Grid can confirm that landowner consent has not been obtained for Change 4 (Reorientation of the Tadcaster West Cable Sealing End Compound (CSEC)) and so this change application does not include Change 4 as detailed in the change notification this is confirmed and evidenced in the Change Application: Report on Proposed Changes (Document 9.1).

The Change Application: Report on Proposed Changes (Document 9.1) sets out that the proposed changes respond to representations received during the examination, further

design work, and on-going engagement with landowners and agents. National Grid consider that the Proposed Changes are non-material and minor in nature, and would not require new land to be compulsorily acquired. As such, the changes would not invoke The Infrastructure Planning (Compulsory Acquisition) Regulations 2010 (CA Regulations) and The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (EIA Regulations) as presented in the documents listed above.

Table 8.1 in the Change Application: Report on Proposed Changes (Document 9.1) sets out the details of all Application documents that would be required to be revised and submitted to the examination should the changes be accepted. National Grid considers it has provided all the required information that the Examining Authority should require in order to determine whether to accept these changes for examination.
