#### Points to Note

The following section of this cover letter confirms National Grid's position in respect of items that the ExA requested to be submitted at Deadline 6 as per the Examination Timetable in the Rule 8 letter (dated 29 March 2023) and any other points to note in respect of Deadline 6.

#### Applicant's updated National Policy Statement schedules of compliance (if required)

National Grid notes the ExA's request, as set out in Annex F, Part 8 of the **Rule 6 letter [PD-005]** for updated **Tables A.1 and B.1 (Appendices A and B)** of the submitted Planning Statement **[APP-202]** which signpost compliance with National Policy Statements (NPS) EN-1 and EN-5. The Examination timetable within the **Rule 8 letter [PD-008]** further sets out that the "Applicant's updated National Policy Statement schedules of compliance (if required)" should be submitted at Deadline 4.

National Grid has reviewed the **Tables A.1 and B.1 (Appendices A and B)** of the **Planning Statement [APP-202]** and considers that there is no update required to the Tables as a result of any of National Grid's Deadline 4 submissions. Furthermore, no new National Policy Statements have been designated during the course of the Examination. Whilst it is noted that a consultation is continuing on Draft National Policy Statements EN-1 and EN-5;

due to the content of the compliances schedules this does not necessitate an update. National Grid will consider at each of the deadlines set out in the **Rule 8 letter [PD-008]** whether any updates are required to this document.

Informing of a further S.102A letter issued as per updated Book of Reference - Leeds City Council – Interest in Land

Leeds City Council were notified under Section 56(2)(a) and (aa) as a prescribed consultee and notified under Section 56(2)(b) as a local authority. Leeds City Council have now been identified as having an interest in land within the Order limits in respect of Warren Lane as updated in the Book of Reference, which now makes them a Section 56(2)(d) person, and therefore we have written to Leeds City Council under Section 102A of The Planning Act 2008.
