Points to Note

The following section of this cover letter confirms National Grid's position in respect of items that the ExA requested to be submitted at Deadline 7 as per the Examination Timetable in the Rule 8 letter (dated 29 March 2023) and any other points to note in respect of this Deadline.

Applicant's updated National Policy Statement schedules of compliance (if required)

National Grid notes the ExA's request, as set out in Annex F, Part 8 of the **Rule 6 letter [PD-005]** for updated **Tables A.1 and B.1 (Appendices A and B)** of the submitted Planning Statement **[APP-202]** which signpost compliance with National Policy Statements (NPS) EN-1 and EN-5. The Examination timetable within the **Rule 8 letter [PD-008]** further sets out that the "Applicant's updated National Policy Statement schedules of compliance (if required)" should be submitted at Deadline 7.

National Grid has reviewed the compliance tables in Appendix A and B of the Planning Statement to check if they require any further updates following submission of the DCO earlier this year. In particular it has considered the changes set out in the **Change Application: Report on Proposed Changes (Document 9.1) [REP5-091]** against the compliance tables. **Document 9.1** confirms that the changes do not alter "the conclusions in the ES regarding significance of effects" and are considered "minor and non-material". As a result of this, and having undertaken a full review of the entire compliance tables, it is National Grid's view that the contents of the compliance tables remain correct and robust and do not need to be updated.

Book of Reference

National Grid has submitted at Deadline 7 an updated and final **Book of Reference** (Document 4.3(G)) and Schedule of Changes to the Book of Reference (Document 8.2(F)) as requested by the Examination timetable. This reflects a further review of the Book

of Reference, land registry refresh and information obtained through on-going liaison with affected parties. Updates have been made to the Book of Reference accordingly with an explanation provided for each change in the Schedule of Changes to the Book of Reference.

Pelagic Energy

In CAH1 and as detailed in the Written Summary of Oral Representations made at Compulsory Acquisition Hearing 1 (Document 8.23.2) [REP4-024] National Grid confirmed that agreement had been reached on 25 May 2023 with Pelagic Energy who are developing a battery storage site at the Monk Fryston substation. The basis of that agreement included provisions that if Yorkshire Water undertake some water pipeline diversion works prior to the close of the examination then an update would be made to amend the Land Plan Section F (Document 2.5.6(B)) [AS-010] and Book of Reference (BoR) (Document 4.3(G)) to remove the area over which Pelagic holds an option from the land plan and BoR (forming part of Plot F-107 on the land plan). Those water pipeline diversion works have not yet been undertaken and so National Grid is not seeking to amend those documents. It is necessary to retain the rights in the dDCO should National Grid need to undertake those works if not first undertaken by Yorkshire Water.

Woodstock Lodge

As detailed in response to ExQ1 Q11.3.1(a) in the **Applicant's Response to Examining Authority's First Written Questions (ExQ1) (Document 8.9.1) [REP2-038]**, National Grid has been engaging with the owners (who are also the operators) of the Woodstock Lodge wedding venue prior to, and throughout the examination process, to reach an agreement to secure funding for the delivery and maintenance of an offsite planting strategy at the wedding venue. The planting strategy has been designed in close consultation with the owners of the wedding venue, and a strategy that meets their requirements has been agreed. National Grid can confirm that a letter of mutual undertaking relating to this planting stagey has been completed by both National Grid and the two owners of the wedding venue.

Protective Provisions and approach to draft DCO

Negotiations regarding protective provisions have continued and for those parties that National Grid has not yet been able to reach agreement, Position Statements on Protective Provisions Not Yet Agreed have been submitted at Deadline 7 (**Documents 8.34.3 to 8.34.6**). Accordingly, draft Statements of Common Ground have been submitted at Deadline 7 with two of these respective parties. Should progress be made and agreement reached with either or both of these statutory undertakers, National Grid will submit final Statements of Common Ground, an updated Statement of Commonality and updated draft DCO at Deadline 8.

Examination timetable: List of matters not agreed where any Statement of Common Ground could not be finalised

The Examination timetable requests at Deadline 7 a list of matters not agreed where any Statement of Common Ground could not be finalised. As detailed in the **Statement of Commonality for Statements of Common Ground (Document 8.5.1(D))**, final versions of Statements of Common Ground have been submitted at Deadline 7. As detailed in the point of note above, only two Statement of Common Ground with statutory undertakers have been submitted in draft form. Table 4.1 of the Statement of Commonality presents in summary form the topics which are matters 'agreed', matters 'outstanding' and matters 'not agreed' across all Statements of Common Ground. Further to this, Section 4.2 of the Statement of Commonality presents further explanation on matters that are 'outstanding' or 'not agreed'. On the basis this information is presented in the Statement of Commonality, no further list is provided in respect of this item on the examination timetable.

Revised National Planning Policy Framework

The National Planning Policy Framework (NPPF) was updated on 5 September 2023 and replaces the previous version of the NPPF (July 2021) considered in the Yorkshire GREEN Environmental Statement and Planning Statement. Paragraphs 155 and 158, and Annex 1 (paragraphs 221 to 223) of the NPPF have been revised. National Grid has reviewed the NPPF revisions against the Environmental Statement and Planning Statement and can confirm that the NPPF revisions do not alter the conclusions of either document. The NPPF paragraphs relating to Green Belt (paragraphs 137 to 151) are unchanged and therefore, with regard to Green Belt matters, the Project continues to accord with the most recent version of the NPPF issued in September 2023.
