CRoW Act 2000 – Section 4 Conclusive Open Country	Land mapped as Conclusive Open Country under the Country Side and Rights of Way Act 2000.
Definitive Map Modification Order	A legal process used to modify existing Public Rights of Way set out in the definitive map of Public Rights of Way.
Mean High Water Springs	The height of mean high water during spring tides in a year.
Morgan and Morecambe Offshore Wind Farms: Transmission Assets	The offshore and onshore infrastructure connecting the Morgan Offshore Wind Project and the Morecambe Offshore Windfarm to the national grid. This includes the offshore export cables, landfall site, onshore export cables, onshore substations, 400 kV grid connection cables and associated grid connection infrastructure such as circuit breaker compounds. Also referred to in this report as the Transmission Assets, for ease of reading.
Long Distance Footpath	These are designated public footpaths typically measuring 20 miles or more in length.
National Cycle Route	These are routes listed on the National Cycle Network, which comprises a UK-wide network of signed paths and routes for walking, wheeling, cycling, and exploring outdoors.
Public Open Space	A collective term used for any land laid out as a public garden, or used for the purposes of public recreation, or land being a disused burial ground. registered parks and gardens, playing fields, allotments, playgrounds, and public beaches.
Public Rights of Way	A right by which the public can always pass along linear routes over land, including footpaths, bridleways, restricted byways, and byways.
Recreational resources	A collective term used for recreational facilities (e.g. livery yards and stables, coastal areas, airports, golf courses and sports facilities), Public Rights of Way (PRoW) and other promoted routes (e.g. National Cycle Routes (NCRs), Long Distance Footpaths)
Study area	This is an area which is defined for each environmental topic which includes the Transmission Assets Order Limits as well as potential spatial and temporal considerations of the impacts on relevant receptors. The study area for each topic is intended to cover the area within which an impact can be reasonably expected.
Survey area	The area within which each survey has been undertaken. This may differ from the Study Area as a Survey Area will be based on species or survey- specific guidance on the extent of survey required, which may be limited by, for example, habitat conditions, or be defined in terms of buffer areas around an area of potential impact.
Transmission Assets Order Limits: Onshore	The area within which all components of the Transmission Assets landward of Mean High Water Springs will be located, including areas required on a temporary basis during construction and/or decommissioning (such as construction compounds).

1 Published recreational resources plan technical report

1.1 Introduction

- 1.1.1.1 This document forms Volume 3, Annex 6.3: Published recreational resources plan technical report of the Environmental Statement (ES) prepared for the Morgan and Morecambe Offshore Wind Farms: Transmission Assets (referred to hereafter as 'the Transmission Assets'). The ES presents the findings of the Environmental Impact Assessment (EIA) process for the Transmission Assets.
- 1.1.1.2 This report provides details of the published recreational resources, within or in proximity to the Onshore Order Limits. This information has been used to inform relevant sections of Volume 3, Chapter 6: Land use and recreation of the ES.

1.2 Methodology

1.2.1 Study area

- 1.2.1.1 The land use and recreation study area (referred to hereafter as 'the study area') comprises all land within the Onshore Order Limits, landward of Mean High Water Springs (MHWS). The following aspects of the environment have been considered within or in proximity to the study area.
 - Recreational resources, including recreational facilities (e.g. livery yards and stables, coastal areas, airports, golf courses and sports facilities), Public Rights of Way (PRoW) and other promoted routes (e.g. National Cycle Routes (NCRs), Long Distance Footpaths).
 - Users of recreational resources, including pedestrians, cyclists, equestrians and other forms of recreational activities.
 - Land used by the local communities, including public open space (e.g. registered parks and gardens, playing fields, allotments, playgrounds and public beaches) and common land and village greens, which are either owned by the Local Authority, privately owned, or belong to the UK Government.
- 1.2.1.2 The location and geographic extent of the study area is presented in **Figure 1.1** to **Figure 1.6** of this report below.





1.2.2 Desktop study

1.2.2.1 Information on recreational resources within or in proximity to the study area was collected through a detailed desktop review of existing studies and datasets. These sources are summarised at **Table 1.1** below.

1.3 Desk study – baseline characterisation

1.3.1 Recreational resources

1.3.1.1 The recreational resources (excluding PRoW) located within the study area are set out in **Table 1.2** below. However, some recreational resources, such as livery yards and stables, are located beyond the study area but likely to utilise recreational resources (e.g. bridleways) within the Onshore Order Limits. Therefore, recreational resources located in proximity to the study area have also been included in **Table 1.2**, where appropriate.






































Figure 1.4: PRoWs within the study area (sheet 1)










Figure 1.5: PRoWs within the study area (sheet 2)










Figure 1.6: PRoWs within the study area (sheet 3)
