1 Response to Section 51 advice

1.1 Introduction

- 1.1.1.1 On the 18th of November 2024, the application by Morgan Offshore Wind Limited ('Morgan OWL') and Morecambe Offshore Windfarm Ltd ('Morecambe OWL') for an order granting Development Consent for the Morgan and Morecambe Offshore Wind Farms: Transmission Assets (hereafter referred to as the 'Transmission Assets') was accepted for examination by the Planning Inspectorate. The Planning Inspectorate provided its advice on the application under section 51 of the Planning Act 2008.
- 1.1.1.2 Morgan OWL and Morecambe OWL, (together, 'the Applicants') have provided its responses to the section 51 advice in Table 1.1.

		• Further due diligence on relevant Statutory Undertakers has been undertaken. Stark UK Property Holdings Limited were previously consulted, however, no longer have an interest in land affected by the proposed development. The Applicants can confirm that the remaining interests listed in Box 6 of the section 55 checklist (excluding National Gas) have no land interest or no apparatus likely to be affected by the proposed development, and as such, were not consulted. National Gas will be notified in accordance with section 56 of the Planning Act 2008.

Land Plan – Onshore	 "The pages on the Land Plan are marked draft which needs to be rectified. The plot boundaries need to be more clearly identified as there are several instances where they are not able to be clearly understood due to other similar lines on the plan (For example, plots 15-026A, 15-030B and18-022). Some of the keys on particular pages of the Land Plan contain categories that are not reflected on the respective plan. The approach to the use of detailed insets is inconsistent. There are several areas on the Land Plans where a detailed inset is needed in order to clearly portray the plots and their boundaries. For example, the immediate areas around plots 06-056, 08-065, 08-095, 11-011, 14-063, 14-088, 16-015, 16-079. The Applicants should provide more detailed insets where necessary to more clearly show the relevant plots. Although the Land Plan shows (coloured yellow) those plots that would only be subject to temporary possession, it does not show that temporary possession may be applicable across all of the Order land, as indicated is sought by the Applicants in the Statement of Reasons." 	The Applicants have updated this document with the requested changes and have submitted it to the Planning Inspectorate (document reference: B10/F02). The document also contains a Schedule of Changes. The Applicants note that the updates to the Land Plan (document reference: B10/F02) have been reflected in the Book of Reference submitted to the Planning Inspectorate (document reference: D3/F02). Statement of Reasons	"The document has no page numbers and contains highlights in paragraph 1.7.1.18."	The Applicants have updated this document with the requested changes (document reference: D2/ F02). Whilst doing so, it became apparent that some text was missing from the end of paragraph 1.1.1.9. The Applicants are advised to review the plans to ensure that the keys and symbols are consistent across all plans and documentation referring to ecological designations."	The Applicants have updated the Onshore Statutory and Non- Statutory Nature Conservation Sites plan to align with the symbology in Offshore Statutory and Non-Statutory Nature Conservation Sites plan and have submitted it to the Planning Inspectorate (document reference: B14/ F02). The Applicants are advised to provide an updated set of figures with appropriate labelling of the features being represented. "	The Applicants have updated this document with the requested changes and have submitted it to the Planning Inspectorate (document reference: B14/F02 and B16/F02). Both documents contain a Schedule of Changes.
Onshore Historic or Scheduled Monument Sites	Between the onshore historic or scheduled monument sites (Doc B16) and ES Volume 3 (Doc F3.12, figures for chapter 5), there appear to be some minor differences in terms of the specific assets recorded between these drawings. An example is Doc F3.12 ES figure 5.7 compared to sheet 3 of Doc B16. The Applicants are advised to provide an updated set of figures which are consistent in the features being represented, with appropriate labelling.	The Applicants have reviewed the Onshore Historic or Scheduled Monument Sites plan alongside the Environmental Statement (ES) Volume 3 Figures and can confirm that the data included is the same. However, the data shown on the ES figures has been separated based on the time period for the records. To facilitate ease of cross-referencing between the documents, labels referencing the heritage asset list entry have been added to the Onshore Historic or Scheduled Monument Sites plan (document reference: B16/F02). The Applicants have submitted the updated Onshore Historic or Scheduled Monument Sites plan (document

The Applicants are advised to provide an updated set of figures with appropriate labelling of the features being represented."	The Applicants have reviewed the Offshore Historic Environment Plan alongside the ES Volume 2, Figure 8.5 and can confirm that the location of the geophysical anomalies shown as high medium and low are the same.
		The Applicants have reviewed the Offshore Historic Environment Plan alongside the ES Volume 2, Figure 8.6 and can confirm that Archaeology Exclusion Zone (AEZs) and Temporary Archaeology Exclusion Zones (TAEZs) are the same. Flood Zone 3a and Flood Zone 3b are not differentiated on the figures in the FRA. An updated FRA with plans differentiating Flood Zone 3a and 3b should be reissued."
