### 1 Guide to the application

#### 1.1 Introduction

- 1.1.1.1 This guide to the application summarises the structure of the application for development consent for the Morgan and Morecambe Offshore Wind Farms: Transmission Assets (referred to hereafter as 'the Transmission Assets'). Its purpose is to provide an understanding of the structure of the Application and the principal contents within each 'category' of documents.
- 1.1.1.2 Updating this document will be an iterative process and new versions will be made available as updates are made.
- 1.1.1.3 This document will be updated during the examination of the application and will be a quick-reference guide to the latest version of the application documents.

#### 1.2 Document categories

- 1.2.1.1 There are seven categories of application documents, as set out in Table 1.1. These follow, wherever possible, the structure described in Table 1 of 'Advice Note 6 – Suggested Order of Information Submitted with Application' (The Planning Inspectorate, 2022).
- 1.2.1.2 These categories, A-J, accord with the Volume document numbering set out in the following 'Annex A: Order of information submitted with NSIP applications', of the Nationally Significant Infrastructure Projects: Advice on the Preparation and Submission of Application Documents (The Planning Inspectorate, 2024).

Categories	Details
A: Application Information	Provides details of the specific application information required by the Planning Inspectorate.
B: Plans	Contains the various plans which show the location of the Transmission Assets, the proposed works or are related to other powers sought in the Development Consent Order.
C: Draft Development Consent Order	This category outlines the legal power sought by the Applicants for the Morgan and Morecambe Offshore Wind Farms: Transmission Assets.
D: Compulsory Acquisition Information	This category includes the Funding Statement, Statement of Reasons and Book of Reference required to be submitted for the Transmission Assets.
E: Reports	This category contains the documents required to be submitted with the application for consent, including the Consultation Report and the Information to Support Appropriate Assessment.
F: Environmental Statement	Details how the Applicants has assessed the potential impact of the Project on the environment, economy and community.
