

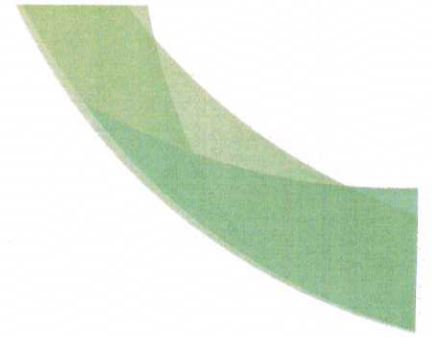

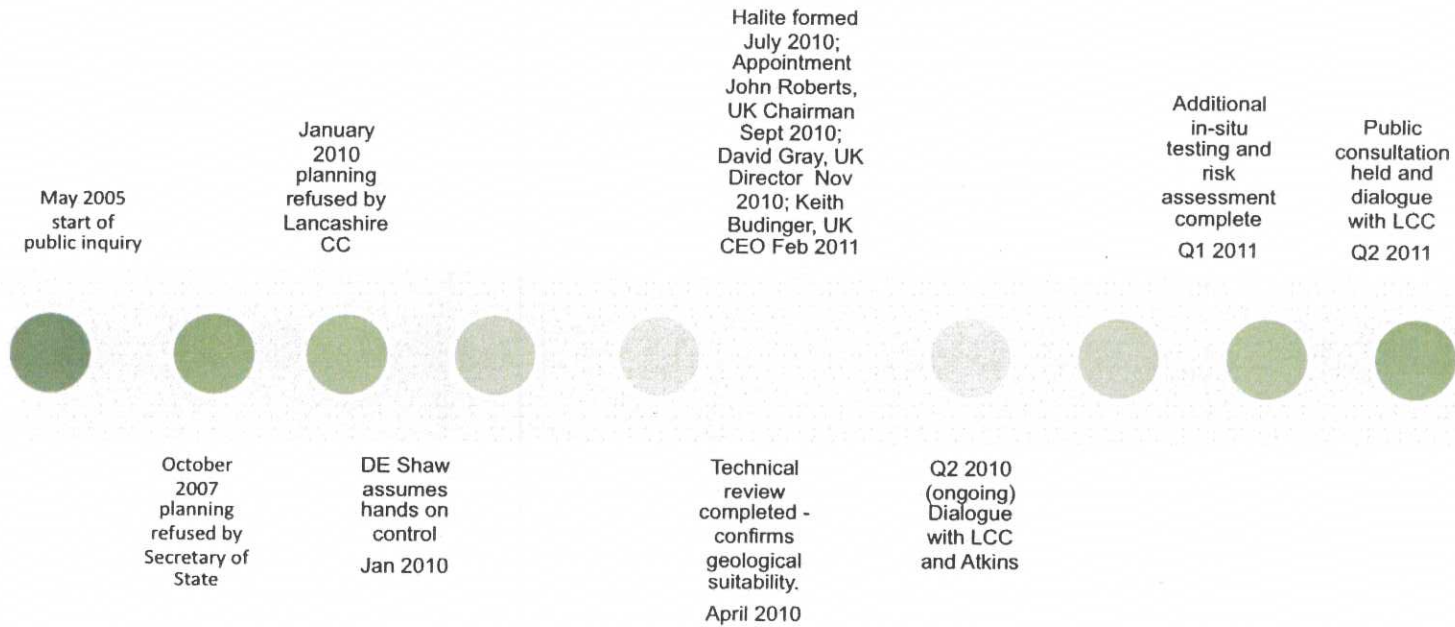

# Public exhibitions

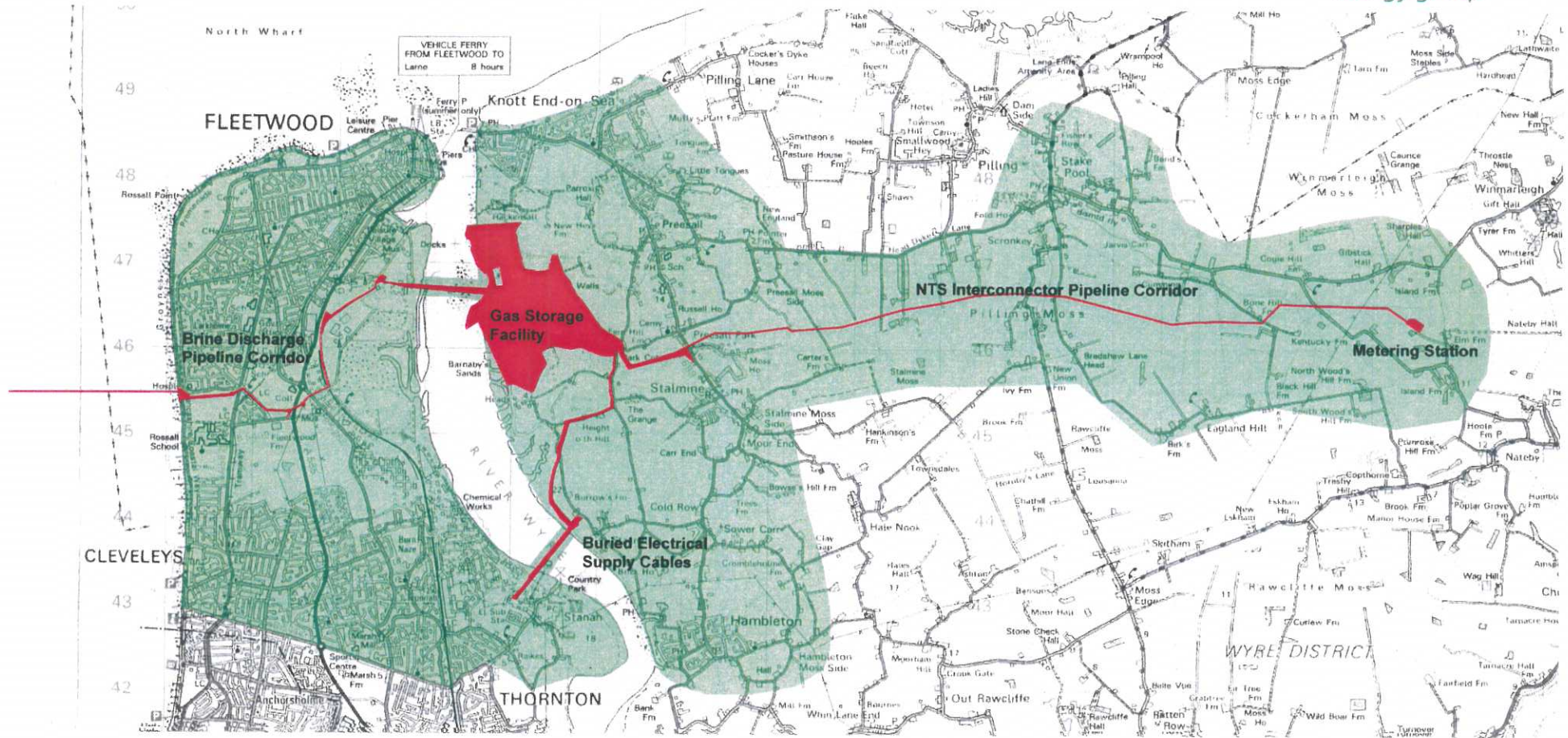
- Stalmine Village Hall
