Thank you for your notification relating to the adequacy of consultation. I have responded earlier today, but I suspect that the "cloud" based email link that automatically populated my screen did not work so I am repeating the content using my own email account the best that I can recollect.

Flintshire County Council welcomes the notification and the opportunity to make comment on the Keuper GSP development proposal. Flintshire borders Cheshire West and Chester Council, however, given the large geographical distance from the development site from our border, we made no specific comment at the pre-application stage with respect to specific amenity, environmental effects or benefits because the zone of influence is unlikely to affect the population of Flintshire. Flintshire may still welcome the opportunity to make comment to the examination process, which is more likely to be on matters of strategic significance, such as the need for gas storage and security, and whether there are any consequential minerals sterilisation issues.

With respect to Sections 42,47 & 48 of the Planning Act (England) we consider that the duties were undertaken and opportunity was afforded to Flintshire to make comment.
