The SoCC describes how the developer has divided up its consultation zones into two categories depending how close they are to the main sites (Consultation Zones, p4-6). 			Zone B rather than just consult through identified stakeholders. The keys on the maps could be clearer and should include the red line boundary in the key. The references to appendices in this section need renumbering as the plans and consultee lists are given the same numbers.

The SoCC lists how it plans to engage with various consultees (Appendices 1 and 2, not provided) affected by the project and tabulates on p.4-5 how it intends to engage with hard to reach groups. The SoCC does not mention how it intends to engage with the transient population such as short term farm labourers. The SoCC does not mention translating documents into foreign languages. Despite the fact that DCLG guidance does not encourage this it might be worth considering if there are communities affected by the project who are nonnative English speakers.
