For those who have not notified the Inspectorate of their intention to attend, unreserved seating will be available, as shown below, from 09.30.

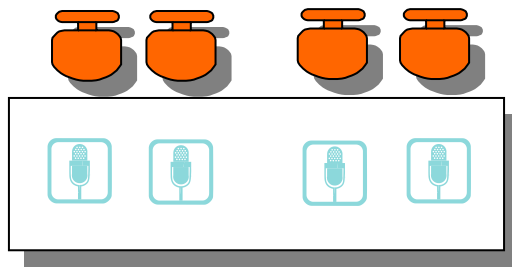
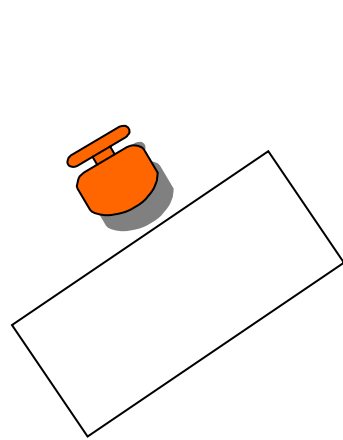
The parties will note that the Preliminary Meeting dictates a theatre-style layout, and accordingly no tables will be available.

If you have any specific access needs that you have not made the Inspectorate aware of then please do not hesitate in contacting us.




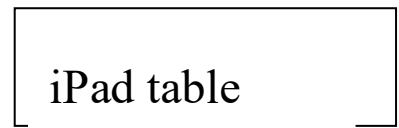
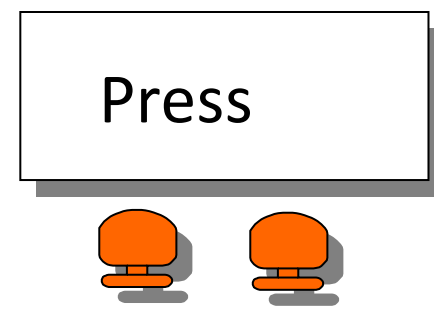
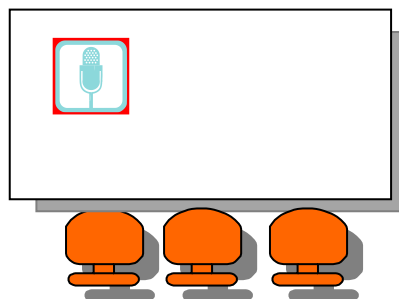
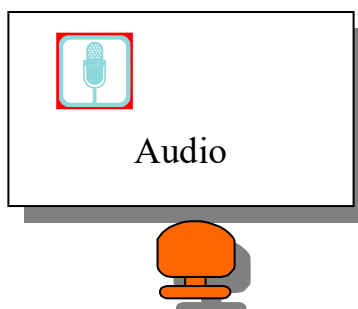
Floor screen for ExA
