# 1 Navigation Document

## 1.1 Navigation Document Overview

### Purpose of this Document

- 1.1.1 This Navigation Document summarises the structure of Esso Petroleum Company, Limited's (Esso) application to the Planning Inspectorate for development consent for the Southampton to London Pipeline (SLP) project (the project) and explains what the documents are. Its purpose is to provide an understanding of the structure of Esso's application and the principal contents within each volume of documents.
- 1.1.2 This document functions as an accessible guide to the project, the applicant and the application and will assist those in reviewing the application documentation. It is intended that the document be updated as the examination of the application proceeds.

## 1.2 Southampton to London Pipeline (SLP) Project

### The Project

- 1.2.1 In December 2017, we began to talk publicly about our intention to replace 90km of our 105km aviation fuel pipeline that runs from our Fawley Refinery near Southampton to our West London Terminal storage facility in Hounslow (the project).
- 1.2.2 The refinery, and its supporting pipeline network, is vital in supporting secure supplies of fuel and other petroleum products for millions of British consumers. This pipeline will help to maintain more than 1,000 jobs at the UK's largest refinery at Fawley, in Hampshire. It also provides fuel to some of the UK's busiest airports and contributes significantly to the regional economy and national infrastructure.

### The Applicant

- 1.2.3 Esso owns and operates the UK's largest refinery at Fawley, which provides fuel for more than 800,000 retail customers every day at Esso-branded service stations. Our underground distribution pipeline network transports fuel from Fawley to our fuel terminals at Avonmouth, Birmingham, Hythe, Purfleet, West London and also for use at the UK's busiest airports.
- 1.2.4 ExxonMobil is one of the UK's largest petrochemical manufacturers with major plants at Fawley, Fife and Newport. ExxonMobil also holds an interest in nearly 40 producing oil and gas fields in the UK North Sea, and a stake in the South Hook Liquefied Natural Gas plant at Milford Haven in Wales, which has the capacity to import 20 percent of the UK's gas demand.



## 1.3 Application Documentation Overview

1.3.1 The reports, drawings and plans that make up the application for development consent have been organised into seven volumes as listed in Table 1.1. The seven volumes are explained in more detail in Section 1.4. Each volume has a unique identifying colour as shown in Table 1.1.
