

#### **EN070007 HyNet Carbon Dioxide Pipeline – Deadline 1**

Please find enclosed the information requested by the Examining Authority (ExA) for Deadline 1 in Annex A (Examination Timetable) of the Rule 8 Letter dated 27 March 2023. A full list of documents submitted at this Deadline can be found in **Table 1** of this letter below.

## National Planning Policy Framework/National Development Management Policies Trackers

It is the view of the Applicant that the policy changes proposed within the National Planning Policy Framework (NPPF) prospectus (December 2022) are not relevant to this Application and as such, using the discretion provided by the ExA in the Rule 8 Letter, the Applicant has not submitted a tracker of this document to avoid surplus information being submitted into the Examination.

Furthermore, the Applicant will comment on any National Development Management Policies (NDMP), if these are released during the Examination. As no NDMP were released before Deadline 1, in accordance with the direction given by the ExA in the Rule 8 Letter, no tracker of this document has been submitted.

# Open Floor Hearing(s), Compulsory Acquisition Hearing(s) and Accompanied Site Inspection(s)

For the avoidance of doubt, the Applicant would like to register its wish to speak at any Issues Specific Hearing(s), Open Floor Hearing(s), Compulsory Acquisition Hearing(s) and attend any Accompanied Site Inspection(s).

#### **Documents submitted as a response to the Written Questions**

Along with the Applicant's responses to the ExA's First Written Questions, the Applicant has also submitted updated documentation at this Deadline which responds to the issues raised in those questions.

#### **Change Request**

The documents that have been submitted at Deadline 1 by the Applicant have not taken into account the Change Request submitted by the Applicant on 27 March 2023. Any document that has been revised and submitted at Deadline 1, has been updated from the latest accepted version before the Change Request was submitted. The Examination Library references in Table 1 reflect this by referring to the version pre-Change Request submission.

#### **Statements of Common Grounds**

Considering the list contained within Annex E of the Rule 6 Letter dated 20 February 2023, **Table 1** includes the stakeholders with which the Applicant has prepared and submitted a draft Statement of Common Ground (SoCG) at Deadline 1. However, as explained in the Statement of Commonality submitted as part of Deadline 1 (with evidence annexed to that document), the following stakeholders have agreed that they do not wish to enter into a SoCG:

- Maritime and Coastguard Agency
- The Coal Authority
- UK Health Security Agency

The Applicant has drafted a number of SoCGs in response to the Inspectorate's Rule 6 letter but is not currently able to share them at Deadline 1. This is because the stakeholder has either not engaged, or has not yet identified a suitable person to progress or complete the SoCG, or was not clear on their requirement for an SoCG or input required to the SoCG at this stage. In all cases, the Applicant will continue to seek and progress dialogue to confirm and establish requirements. This relates to the following stakeholders:

- Welsh Water
- Exolum Pipeline Systems
- Scottish Power Energy Networks (SPEN)
- Health and Safety Executive
- Royal Mail Group Limited
- Woodland Trust

The Applicant is also preparing some additional SoCG's that were not included in the Inspectorate's Rule 6 letter and are not included in the Deadline 1 submission but are intended to be included at a future Examination Deadline. This includes the following stakeholders:

#### **Outline Public Rights of Way Management Plan**

The Applicant has submitted an Outline Public Rights of Way Management Plan (OPRoWMP) (document reference: **D.7.9**). The purpose of this document is to provide management principles and measures for the Public Rights of Way that conflict with the DCO Proposed Development.

#### **Outline Operational and Maintenance Environmental Management Plan**

The Applicant has submitted an Outline Operational and Maintenance Environmental Management Plan (OMEMP) (document reference: **D.7.15**). The purpose of this document is to provide a control plan which sets out indicative methods to avoid, minimise and mitigate possible environmental effects during the operation and maintenance of the DCO Proposed Development.

#### Applicant's update on the Marine Licence (ML) submission and progress

The Applicant is currently compiling a Marine Licence application to Natural Resources Wales (NRW) for the licensable works that relate solely to the River Dee crossing. The Applicant has discussed with the relevant Case Officer at NRW and alongside the application form, has agreed to provide the relevant extracts from the ES that relate to the works, including the Water Framework Directive (WFD) Report and Habitats Regulations Assessment (HRA). The Applicant plans to submit the Marine Licence application to NRW by 23 May 2023 (i.e. Deadline 3).
