

EN070007 HyNet Carbon Dioxide Pipeline – Change Request 2

Further to the Applicant's submission of its Notification of Intention to Submit a Change Request 2 on 03 May 2023 [AS-066] please find enclosed the Applicant's Change Request 2.

A full list of documents submitted as part of Change Request 2 can be found at **Table 1**. Two types of documents are included:

- Revisions of previously submitted documents incorporating Change Request 2;
 and
- New documents providing information solely in respect of Change Request 2.

A detailed description of each change and its justification can be found in the Notification of Intention to Submit a Change Request 2 [AS-066] and is summarised below:

Change 1: The introduction of optionality for the Alltami Brook crossing at Work No. 43, consisting of an alternative option for an embedded pipe bridge. This will act as an alternative to the Applicant's preferred trenched crossing of Alltami Brook as included in the Application (Applicant's reference PS25), and change to the compulsory acquisition sought from sub-surface interests only to full acquisition to allow for the above ground bridge;

Change 2: The addition and removal of small parcels of land to the Order Limits at Work No. 34 to optimise temporary construction access near Chester Road East so as to minimise impacts on 2 Sisters Food Group (Applicant's reference PS26), and change to the compulsory acquisition sought.

Extent of information submitted at Change Request 2

In the interests of clarity and to simplify the information submitted at Change Request 2, the Applicant felt it prudent to only provide/update information which is directly relevant in enabling the Examining Authority (ExA) and Interested Parties (IPs) to understand

and comment on Change Request 2 and, in the case of the ExA, take a decision on whether Change Request 2 should be accepted into the Examination.

It is proposed that a full suite of plans/drawings and other documents including, but not limited to, the documents listed below, will be updated if Change Request 2 is accepted by the ExA:

- Register of Environmental Actions and Commitments (REAC) [REP2-017];
