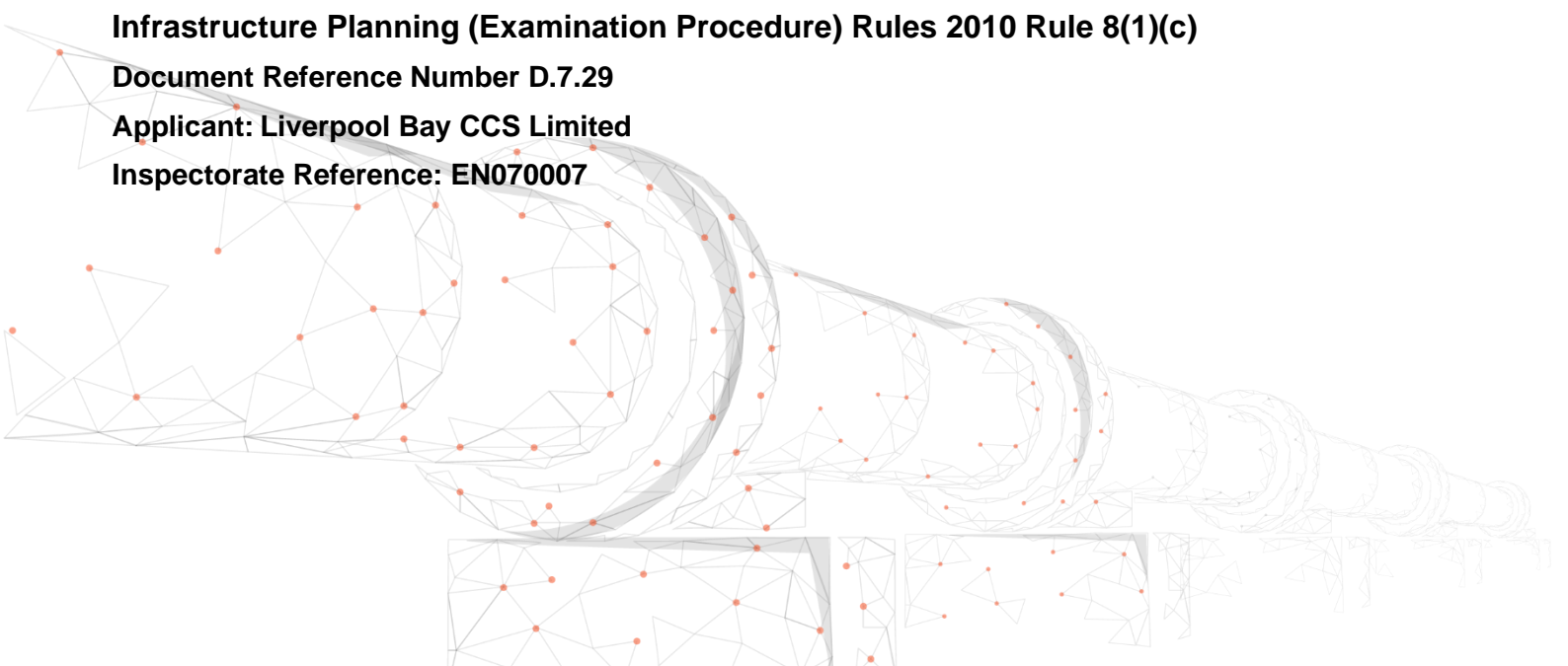

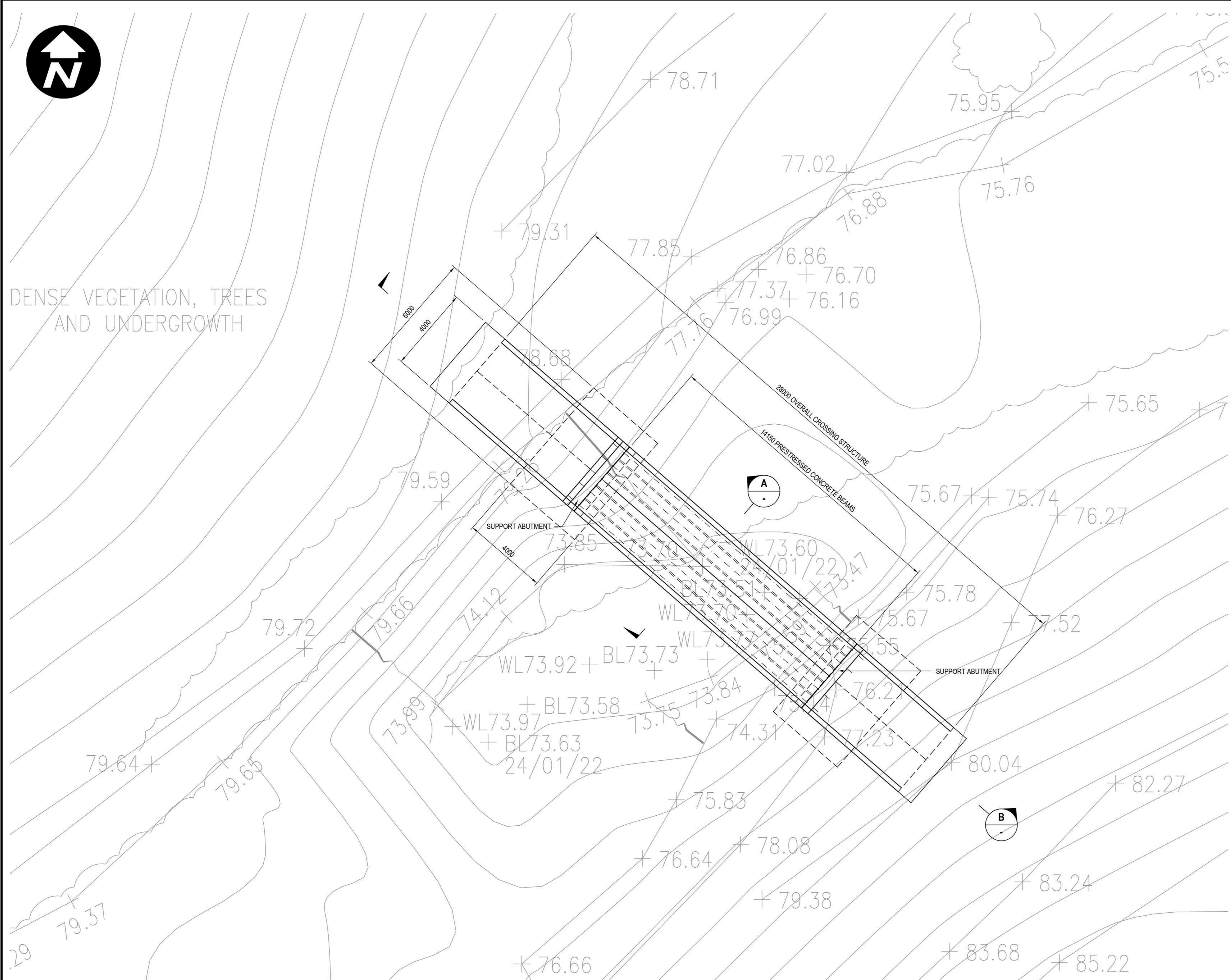

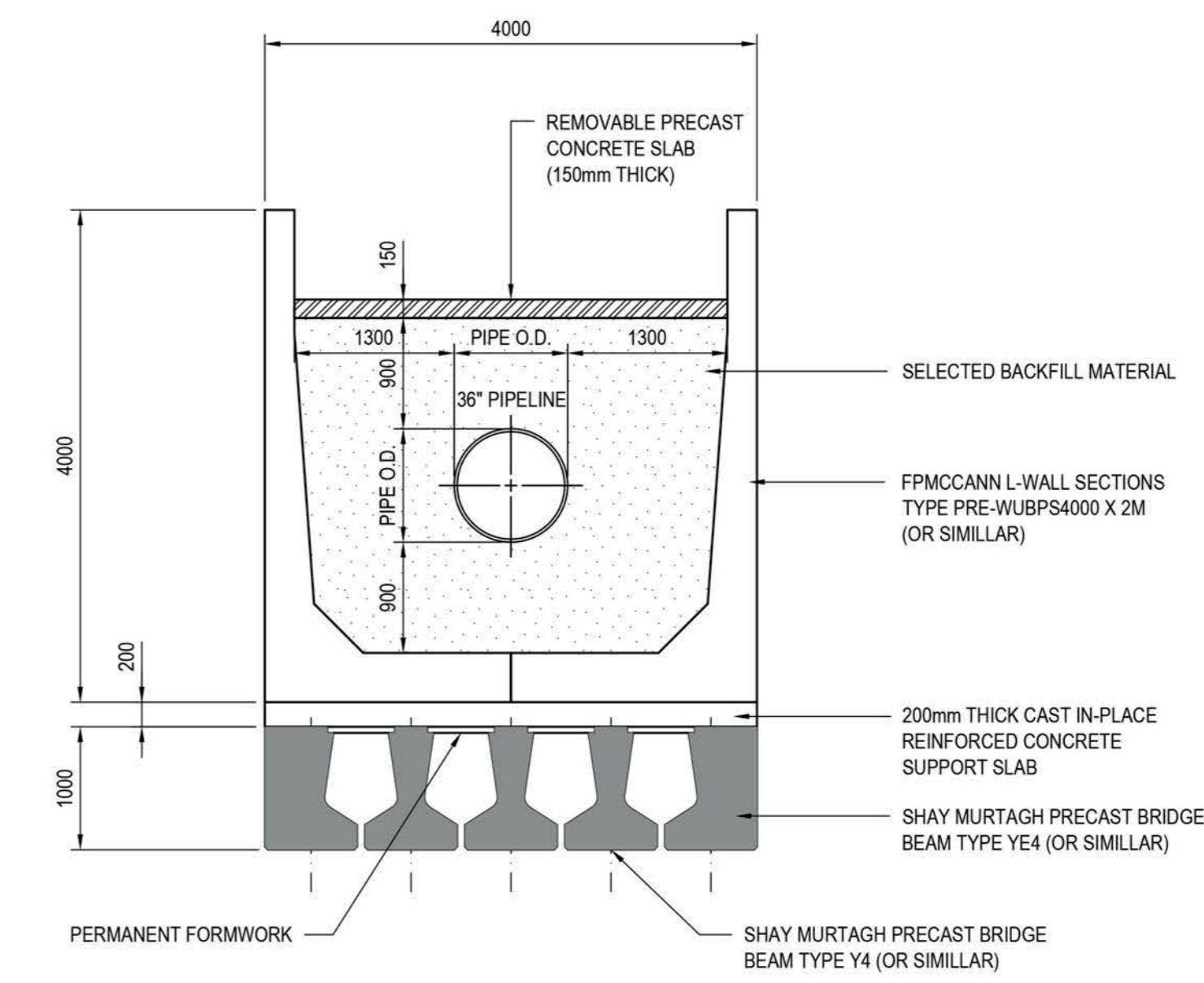




DENSE VEGETATION, TREES AND UNDERGROWTH

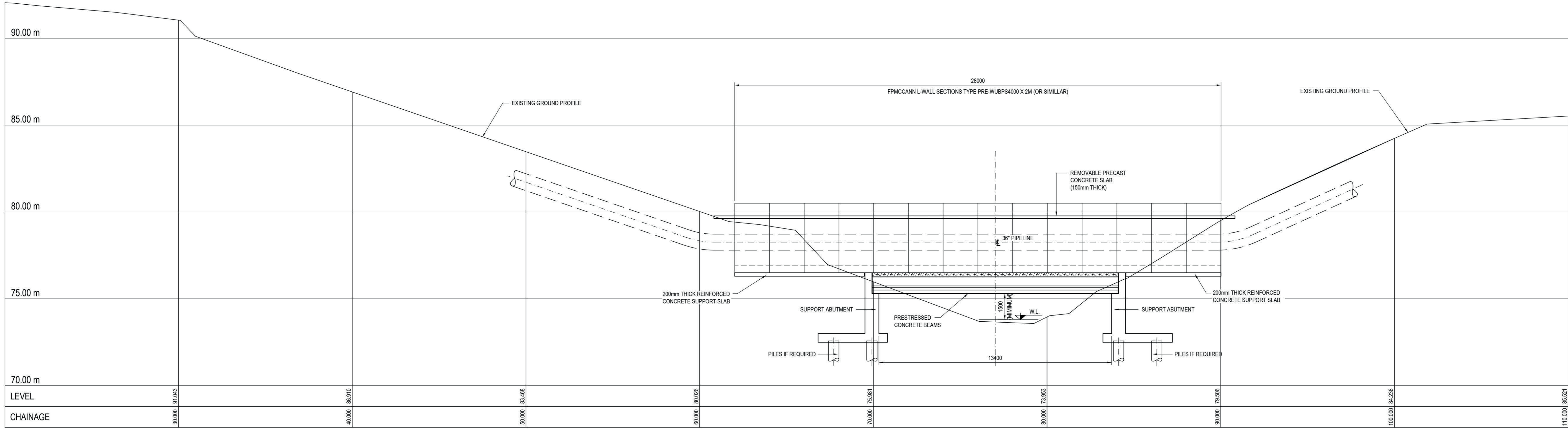
