The Applicant's submitted suggested locations for ASIs at procedural deadline A [PDA-002] and was updated at Deadline 1 [REP1-040], in response to various suggested locations of ASI from Interested Parties (IP). The ExA notes the submissions from IPs regarding suggested locations for ASI, including those from: Flintshire County Council [PDA-005]; Peel NRE [PDA-009] and [REP1-073]; Stephens Scown on behalf of S and C Oultram [PDA-006] and [REP1-082]; and Rostons on behalf of E C Craven-Smith-Milnes and A D W Griffith [REP1-079] and R B Jones [REP1-081].

The ExA has carefully considered all locations suggested by IPs when compiling the final itinerary for the ASI, which is set out in **Annex A** of this letter. Please note that ASIs are **not** an opportunity to provide any oral representations on the project or discuss evidence. It is an opportunity for the Examining Authority (ExA) to look at the physical features that can be seen on, or from the sites. Participants may be invited by the ExA to point out specific features or sites of interest.

Joining the ASI

ASI1 and ASI2 will commence promptly leaving from Crowne Plaza Hotel, Trinity Street, Chester, CH1 2BD. Please note the start times for the ASIs differ, with ASI1 on 7 August 2023 commencing 1:00pm and ASI2 on 8 August 2023 commencing 9.30am. All attendees are asked to assemble promptly by the start time as the ExA will not wait for parties who are not present at that time. Attendees will need to organise their own transport to the ASI, and parts of the ASI will be on foot.

Should any attendees wish to leave the ASI at any stage they will need to make their own travel arrangements from the SP they leave the ASI. Attendees should advise the Case Team when confirming their attendance at which SP they intend to leave the ASI. For any attendee meeting the ASI at a specific SP, they should note timings and locations of the
