

Please find enclosed the information requested by the Examining Authority (ExA) for Deadline 4 in Annex A (Examination Timetable) of the Rule 8 Letter dated 27 March 2023. A full list of documents submitted at this Deadline can be found in **Table 1** of this letter below. Updates to ES (Volume 6) documentation, including the Consolidated ES with the Change Requests accepted by the ExA (requested by the ExA for Deadline 4), can be found in **Appendix 1** of this letter below.

National Planning Policy Framework/National Development Management Policies Trackers

No updates have been made to the draft National Planning Policy Framework (NPPF) since Deadline 3 and as such it remains the view of the Applicant that the policy changes proposed within the NPPF prospectus (December 2022) are not relevant to this Application. Therefore, using the discretion provided by the ExA in the Rule 8 Letter, the Applicant has not submitted a tracker of this document to avoid surplus information being submitted into the Examination.

The Applicant will comment on any National Development Management Policies (NDMP) if these are released during the Examination. As no NDMP were released in advance of Deadline 4, in accordance with the direction given by the ExA in the Rule 8 Letter, no tracker of this document has been submitted.

National Policy Statement Tracker

No updates have been made to the compliance assessment in the National Policy Statement Tracker for Deadline 4, as such this has not been submitted, in accordance with the direction given by the ExA in the Rule 8 Letter.

Statement of Progress on SoCGs

Table 1 includes the stakeholders for which the Applicant has prepared and submitted a draft Statement of Common Ground (SoCG) at Deadline 4.

The updated Statement of Commonality (SoC) submitted at Deadline 4 outlines the position of all SoCGs that the Applicant has, intends to, or intends not to enter into with relevant stakeholders/IPs. Stakeholders/IPs in the last category have specifically stated they do not wish to enter into an SoCG with the Applicant. Further details on the status of all SoCG's are provided in Table 2-1 of the SoC.

The Applicant has drafted a number of SoCGs in response to the ExA's Rule 6 letter **[PD-011]** but is not able to share them at Deadline 4 as engagement has been delayed with the stakeholder/IPs or because certain matters need to be discussed before they are able to agree an SoCG for submission. This relates to the following SoCG's:

- Welsh Water
- Scottish Power Energy Networks (SPEN)
- Health and Safety Executive (HSE)

The Applicant is also preparing additional SoCGs that were not included in the ExA's Rule 6 letter **[PD-011]** and are not included in the Deadline 4 submission but are intended to be included at a future Examination deadline. As noted above, engagement with these stakeholders/IPs is in progress, or certain matters need to be discussed before they are able to agree an SoCG for submission. This includes the following SoCGs:

- Wales & West Utilities
- Enso Energy (land at Picton)
- Shell
- Anesco (Land at Thornton Le Moors)
- Vertex Hydrogen Limited
- Cadent Hydrogen DCO
- Redrow PLC

The Applicant has provided an update in previous Cover Letters on the status of SoCGs that are not required at the stakeholders' request **[REP1-001]** or due to the stakeholder going into administration **[REP2-001]** and therefore no further updates are required at this deadline.

The Applicant submitted an SoCG with United Utilities **[REP1-035]** for Deadline 1. However, United Utilities has since noted their intention to focus discussions solely on Protective Provisions. Therefore, as it stands, the Applicant does not envisage that this SoCG will be signed and submitted by the close of Examination.

Applicant's update on the Marine Licence (ML) submission and progress

A ML application for the licensable works at the River Dee was submitted by the Applicant to Natural Resources Wales (NRW) on 19 May 2023. Since the first round of hearings in week commencing 05 June 2023, the Applicant and NRW have been in discussion on the format of the further information for that application. The Applicant considers that all of the information is fully set out in the ES and HRA for the DCO, and given the deferrals agreed has signposted to that. However, NRW have requested that this information is disaggregated from the wider application and presented as standalone for the marine

licence. This work is being undertaken but, given the volume of material and the need to create bespoke summaries and other administrative points, this work is taking longer than originally allowed in the further information request. NRW have therefore requested that the application be withdrawn and re-submitted once that has been finished. The Applicant will update when this has been completed.

Protective provisions

The Applicant has not provided public comments as part of its Deadline 4 submissions on proposed Protective Provisions submitted by IPs at Deadlines 1, 2 and 3 due to the nature of these discussions. The Applicant is continuing to engage directly with IPs on this and other matters and a summary is provided in the relevant SoCGs.

Items in which the Applicant has not provided a response

The Applicant has not provided a response at Deadline 4 where the IP's submission does not contain any substantive points to which a reply is required, or no comment has been provided by the IP. Deadline 3 submissions where a response has not been provided have been listed in the Introduction section of the Applicant's Comments on Submissions Received at Deadline 3 (document reference: **D.7.28**).

Change Work No. 16A and Work No. 16B to remove part the access at Picton Lane

The Applicant has submitted updated Land Plans (document reference: **D.2.2**) and Works Plans (document reference: **D.2.4**), which shows the removal of land from the accesses off Picton Lane (Work Nos. 16A and 16B), in response to landowner/ExA concerns raised in private conversations, examination documentation and at the hearings.

Applicant's Responses to Action Points from the Hearing of week commencing 05 June 2023

The Applicant has responded to the action points arising from Issue Specific Hearing 1, Compulsory Acquisition Hearing 1 and Issue Specific Hearing 2 **[EV-026]** in *Applicant's Responses to Action Points raised at hearings held week commencing 5 June* (document reference: **D.7.31**), submitted at Deadline 4.

Some action points have been dealt with by the Applicant in *Written Summaries of oral submissions made at hearings held week commencing 5 June* (document reference: **D.7.30**); in these circumstances, the Applicant has cross-referenced to D.7.30 in D.7.31, to avoid duplication.

Applicant's response to action from Issue Specific Hearing 2 regarding *"robust project management team"*

At Issue Specific Hearing 2, the ExA requested the Applicant explain how it aims to secure the *"robust project management team"* which the Applicant had referred to in Examination documents. It is understood that the ExA is referring to 2.1.5 of the Applicant's Response to Relevant Representations **[REP1-042]**, in which the Applicant states:

"The Applicant's appointed construction contractor would hold CDM responsibilities over all construction areas. The Applicant shall employ a robust project management team, including SH&E resource, to assure contractor activities."

This was in response to 2 Sisters Food Group Relevant representation (RR-001) which states: *"Please confirm what SH&E resource Hynet will appoint to support the installation phase?".*

The Applicant can confirm that the Stakeholder Communications Plan will contain the commitment for an SH&E resource. This Plan will form part of the Outline Construction Management Plan (OCEMP) **[REP2-021]** and is secured by Requirement 5 of the draft Development Consent Order (dDCO) **[CR2-008]**. As stated by the Applicant at ISH2, the Applicant aims to submit the Stakeholder Communications Plan at Deadline 5.

Applicant's Response to Rule 16 Letter of 15 June 2023

The Applicant acknowledges the Rule 16 Letter of 15 June 2023 regarding the Accompanied Site Inspection (ASI) and would like to again confirm its intention to attend. Furthermore, the Applicant can confirm that it will provide both a health and safety briefing, personal protective equipment (PPE) and transport arrangements, in the accordance with the Rule 16 Letter.
