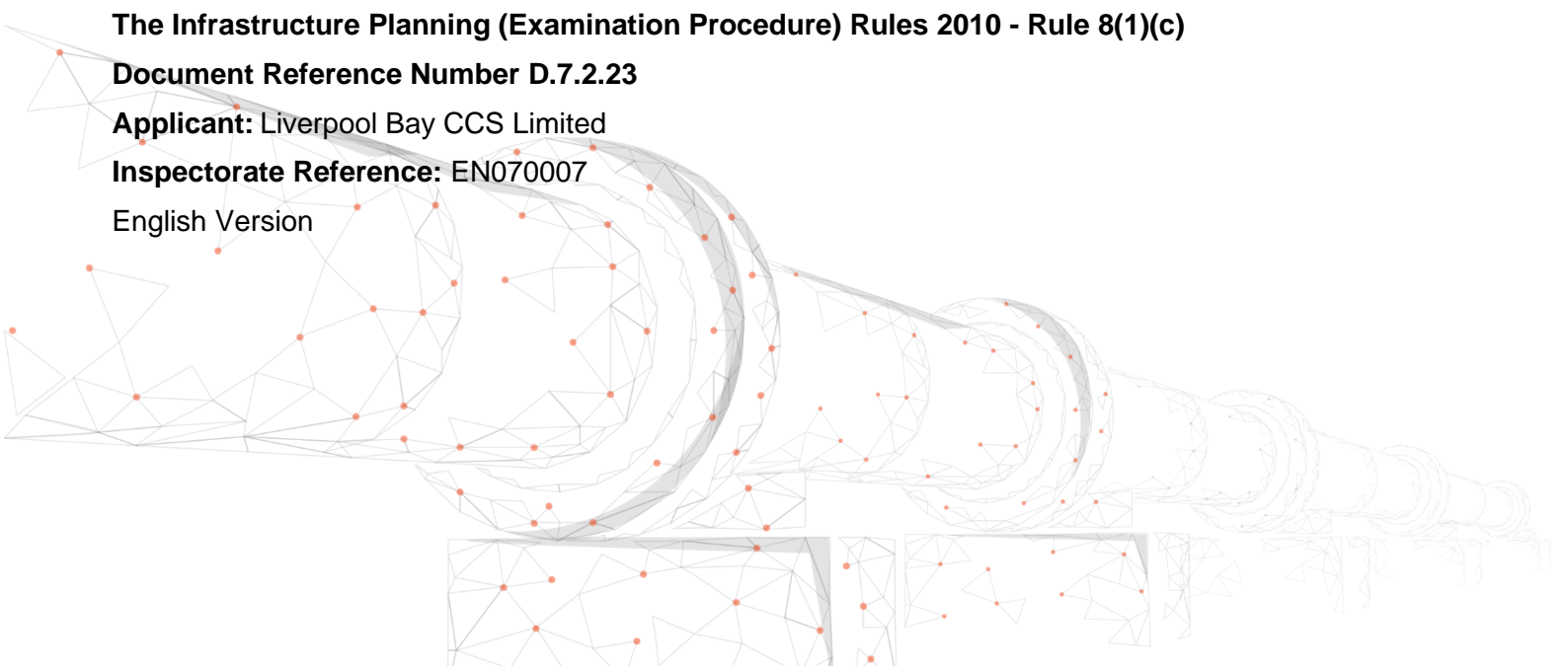

# 1. INTRODUCTION

---

## 1.1. PURPOSE OF THIS DOCUMENT

- 1.1.1. This draft Statement of Common Ground (SoCG) has been prepared by Liverpool Bay CCS Limited ('the Applicant') and Wales and West Utilities (WWU).
- 1.1.2. For the purpose of this draft SoCG, the Applicant and Wales and West Utilities will jointly be referred to as the 'Parties'.
- 1.1.3. The purpose of this draft SoCG is to set out the agreement that has been reached between the Parties in respect of a number of matters related to the Development Consent Order (DCO) Proposed Development. It also lists any points on which discussions are ongoing. SoCGs are an established means in the Development Consent Order (DCO) planning process of allowing all Parties to identify and focus on specific issues that may need to be addressed during the examination.
- 1.1.4. **Chapter 2** of this draft SoCG records the consultation undertaken with Wales and West Utilities by the Applicant. **Chapter 3** of this draft SoCG sets out the areas of agreement in relation to the above matters, and any areas of ongoing discussion between the Parties.

## 1.2. THE DCO PROPOSED DEVELOPMENT

- 1.2.1. HyNet (the Project) is an innovative low carbon hydrogen and carbon capture, transport and storage project that will unlock a low carbon economy for the North West of England and North Wales and put the region at the forefront of the UK's drive to Net-Zero. The detail of the Project and the DCO Proposed Development can be found in the main DCO documentation. The DCO Proposed Development and this SOCG relate to the onshore CO<sub>2</sub> pipeline element of HyNet only. Other elements of HyNet are subject to separate consenting processes and are not addressed here.
- 1.2.2. The DCO Proposed Development impacts Wales and West Utilities as a utility provider and landowner.
- 1.2.3. The Applicant has identified the following plots in which Wales and West Utilities hold an interest:

- 1.2.4. A full description of the DCO Proposed Development is detailed in Chapter 3 of the Environmental Statement (ES) **[APP-055]**. On 27 March 2023, the Applicant's submitted a Change Request which includes '2023 ES Addendum

Change Request 1' [**CR1-124 to 126**] and ES Addendum Chapter 3 provides an update to the description of the DCO Proposed Development [**APP-055**]. On 2 June 2023, the ExA accepted the Applicant's Change Request 2; subsequently the description of the development has been updated, to include Chapter 3 of the 2023 ES Addendum Change Request 2 [**CR2-017**].

### **1.3. TERMINOLOGY**

- 1.3.1. In the Issues tables in **Chapter 3** of this draft SoCG, 'Agreed' and 'Not Agreed' indicates a final position, and 'Under Discussion' indicates where these points will be the subject of on-going discussion wherever possible to resolve or refine, the extent of disagreement between the Parties.

**Discussions and Outcomes**

The Applicant clarified that it is the 36" pipeline which transects assets under WWU ownership and shared a summary of the number of assets (and their locations). WWU confirmed that the details on the Applicant's asset searches are correct in respect of the WWU pipeline in the vicinity of the works. Trial holes will be required to confirm the exact location of the WWU assets prior to work commencing.

The Applicant confirmed that the crossing methods are indicative and to be finalised by the Applicant's Construction Contractor.

The Applicant confirmed receipt of WWU standards (SSW22 & Plant Protection General Conditions) and confirmed that this will be shared with the Construction Contractor once appointed.

WWU advised that a number of their assets within the Order Limits are located at the Chester Road East crossing. The Applicant confirmed that the type of crossing being used at that location will avoid impact to the WWU assets. The Applicant confirmed that they will comply with WWU standards . WWU confirmed that their asset for the Open Trench Crossing on Moor Lane is a smaller pipe and closer to ground level.

WWU requested an update with regard to scheduling post determination. The Applicant confirmed the indicative schedule as anticipated for Q1 2025 and works are anticipated to commence in Q1 2025. This will be confirmed once the Construction Contractor is appointed.
