# 1. INTRODUCTION

---

- 1.1.1. This Appendix provides a summary of the calculated environmental effects relating to Traffic and Transport for the DCO Proposed Development. It should be noted that these are calculated effects only and do not consider the following matters:
- **Duration** – all effects associated with the DCO Proposed Development would be temporary in nature.
  - **Baseline traffic and HGV volumes** – magnitudes of impacts are calculated based on percentage increases in LGV and HGV traffic. Due to the rural nature of many of the sites for proposed infrastructure associated with the DCO Proposed Development, baseline traffics flows – particularly for HGVs – are very low.
  - **Absolute increases in LGV and HGV traffic** – absolute increases in LGVs and HGVs along construction traffic routes are often low however report high percentage increases when compared to low baselines of traffic.
  - **Reasonable Worst Case Scenario** – The project peak month has been assessed. Traffic flows during this period are often significantly higher than for an average month during the construction programme.
- 1.1.2. The impact of these considerations in reporting final residual effects is provided in **Chapter 17 Traffic and Transport (Volume II)**.
