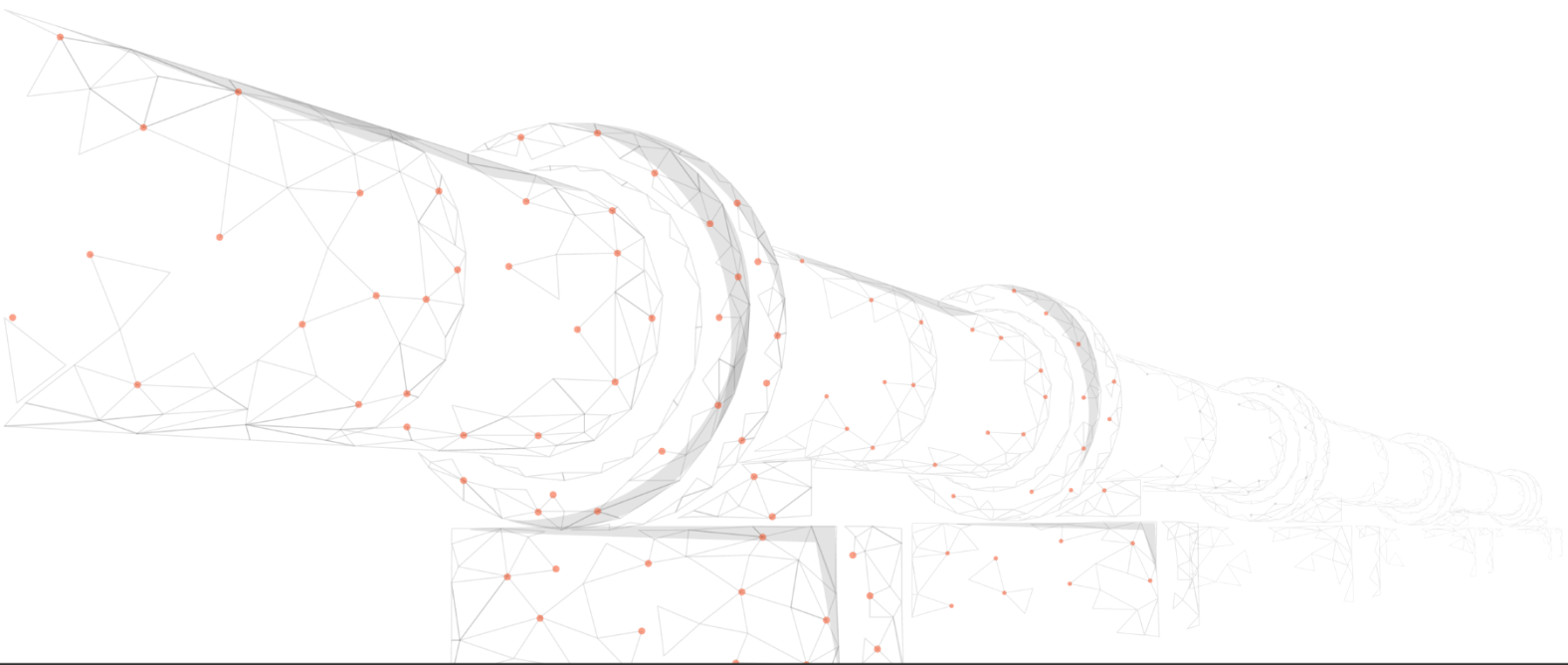

Please find enclosed the information requested by the Examining Authority (ExA) for Deadline 7 in the amended Examination Timetable at Annex A of the Rule 8(3) Letter dated 18 July 2023. A full list of documents submitted at this deadline can be found in **Table 1** of this letter below.

National Planning Policy Framework/National Development Management Policies Trackers

No updates have been made to the draft National Planning Policy Framework (NPPF) for Deadline 7 and as such it remains the view of the Applicant that the policy changes proposed within the NPPF prospectus (December 2022) are not relevant to this Application. Therefore, using the discretion provided by the ExA in the Rule 8 Letter, the Applicant has not submitted a revision of this document to avoid surplus information being submitted into the Examination.

The Applicant will comment on any National Development Management Policies (NDMP) if these are released during the Examination. As no NDMP were released in advance of Deadline 7, in accordance with the direction given by the ExA in the Rule 8(3) Letter, no tracker of this document has been submitted.

National Policy Statement Tracker

No updates have been made to the compliance assessment in the National Policy Statement Tracker for Deadline 7, as such this has not been submitted, in accordance with the direction given by the ExA in the Rule 8(3) Letter.

Compulsory Acquisition/Temporary Possession Schedule

No updates have been made to the Compulsory Acquisition/Temporary Possession Schedule at Deadline 7 and as such the version submitted at Deadline 1 **[REP1-049]**, should be considered by the Applicant to be the final version.

Applicant's responses to action points raised at hearings held week commencing 07 August 2023

The Applicant's responses to action points raised at hearings held week commencing 07 August 2023 have been provided within "*Written Summaries of oral submissions made at hearings held week commencing 7th August*" (document reference: **D.7.59**).

Statement of Progress on Statements of Common Ground

Table 1 includes the stakeholders for which the Applicant has prepared and submitted a draft or signed SoCG at Deadline 7. The Applicant has also previously submitted final signed SoCG's at Deadline 6a:

- Historic England [**REP6A-009**]
- Cadw [**REP6A-010**]
- The Woodland Trust [**REP6A-015**]

The updated Statement of Commonality (SoC) (document reference: **D.7.2**) submitted at Deadline 7 outlines the position of all SoCGs that the Applicant has, intends to, or intends not to enter into with relevant stakeholders/Interested Parties (IPs). Stakeholders/IPs in the last category have specifically stated they do not wish to enter into an SoCG with the Applicant. Further details on the status of all SoCG's are provided in Table 2-1 of the SoC.

The Applicant is aware of the ExA's request to provide all final SoCGs by Deadline 7 and has been working to achieve this with stakeholders. However, due to ongoing discussions or delayed response times, it is expected that the following SoCG's will need to be submitted for Deadline 8 to resolve certain outstanding SoCG matters.

- Cheshire West and Chester Council (CWCC)
- Environment Agency
- Cadent Gas
- Essar Oil (UK) Limited
- British Pipeline Agency (BPA)
- National Grid Electricity Transmission (NGET)
- United Utilities
- Exolum Pipeline Systems
- National Gas Transmission
- Wales & West Utilities
- Network Rail (also submitted for Deadline 7)
- 2 Sisters Food Group (Amber Real Estate)
- Vertex Hydrogen Limited
- Encirc Limited

The Applicant was asked by the ExA in their Rule 6 letter [**PD-011**] to draft SoCG's for named stakeholders. The only SoCG outstanding which the Applicant has not been able to progress, and which cannot be submitted is:

- UK Health and Safety Executive (HSE).

The Applicant has been undertaking direct and regular engagement with HSE since 2021, including face to face and Teams meetings, covering all relevant safety aspects and the related regulatory requirements and processes applicable to the DCO Proposed Development. To date HSE have not raised any significant issues in respect of the DCO Proposed Development. This engagement is an ongoing process and will continue through all future phases of the project development, into and including operation of the infrastructure. The engagement process to date has included discussion of the requirements related to the DCO application and examination process, including for a SoCG. During this engagement process, HSE have not expressed any requirement to establish a SoCG. As such, no SoCG with HSE is included with this submission.

The Applicant previously advised the ExA that it was preparing additional SoCGs that were not included in the ExA's Rule 6 letter **[PD-011]** but may be included at Deadline 7. The Applicant confirms that it is no longer taking forward the following SoCGs as there has not been further engagement from the stakeholders and they have not raised any further issues or concerns:

- Enso Energy; and
- Redrow PLC.

The Applicant has provided an update in previous Cover Letters on the status of SoCGs that are not required at the stakeholders' request **[REP1-001]** **[REP5-001]**, or due to the stakeholder going into administration **[REP2-001]** or due to the suspension of engagement efforts with a stakeholder who has not been forthcoming with replies on the SoCG **[REP6-001]**. Therefore, no further updates are required at this deadline.

Applicant's final update on the Marine Licence submission and progress

The Applicant can confirm the updated Marine Licence application was submitted to NRW on 1 September 2023 and an acknowledgement was received on 4 September 2023.

Protective Provisions

The Applicant has provided comments as part of its Deadline 7 submissions on the proposed Protective Provisions in the update on DCO drafting (**document reference D.6.7.62**). The Applicant is continuing to engage directly with IPs on this and other matters.

Items in which the Applicant has not provided a response

The Applicant has not provided a response to Deadline 6 and Deadline 6A submissions where the IP's submission does not contain any substantive points, or where no comment has been provided by the IP. The Deadline 6 and Deadline 6A submissions where a response has not been provided has been listed in the Introduction section of the Applicant's Comments on Submissions Received at Deadline 6 and Deadline 6A (document reference: **D.7.56**).

Applicant's update on the WFD Assessment

The Deadline 7 updates to the Water Framework Directive (WFD) Assessment, since the previous submission at Deadline 4 [REP4-174], comprise amendments to respond to IP comments requesting further clarification or explanation of the assessment during the Examination and as a result of the SoCG process. The updates do not change the overall scope or conclusions of the assessment reported and do not comprise any new environmental information.

Final versions of Environmental Statement (ES) documentation

The Applicant has submitted at Deadline 7 final versions of all ES documentation (Volume 6), incorporating all changes made during the examination to date. A full list of submitted ES documentation can be found at **Appendix 1** of this cover letter.

Crown Land Consent

The Applicant can confirm that the Secretary of State for Defence confirmed in a letter dated 31 August 2023 that it gives Crown Consent in accordance with section 135 of the Planning Act 2008 to the compulsory acquisition of its interests and agrees to the wording in Article 41 of the draft DCO [CR3-008]. A copy of this letter is provided at **Appendix 2** of this cover letter.

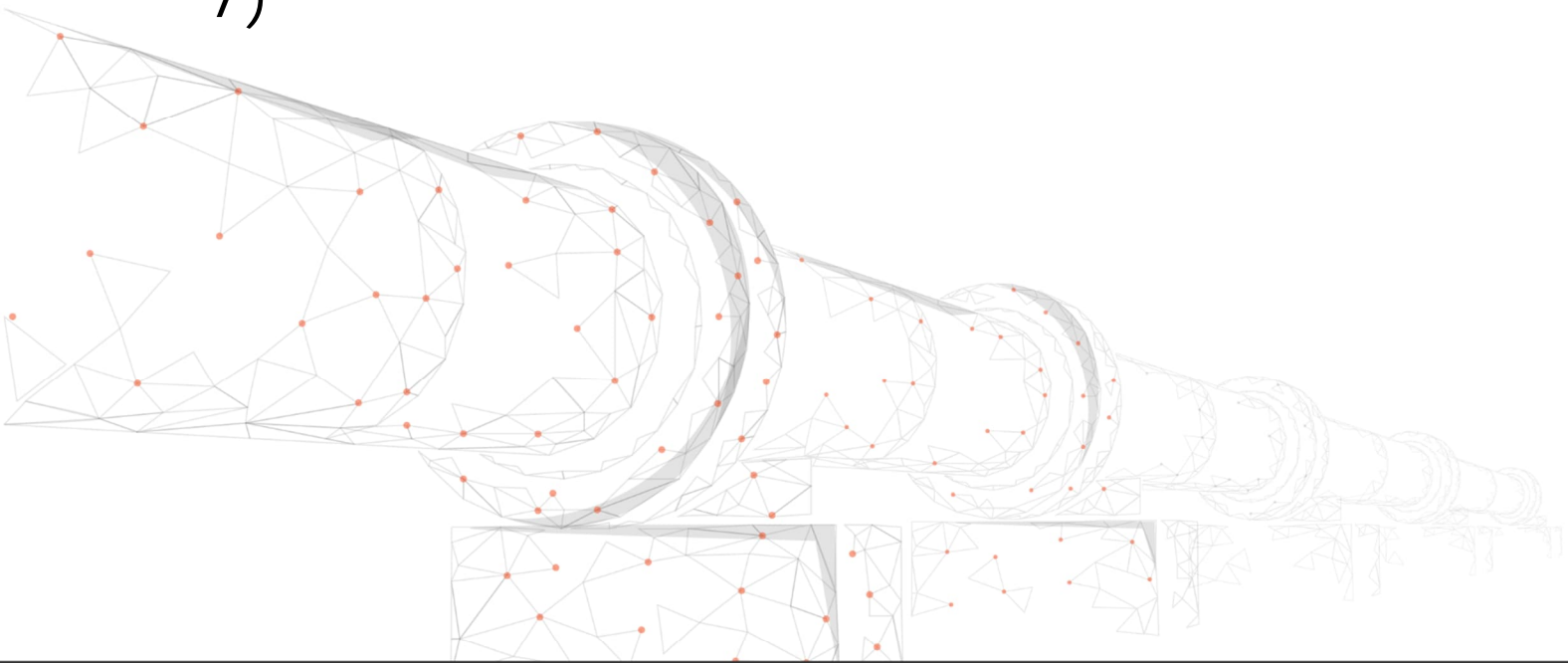

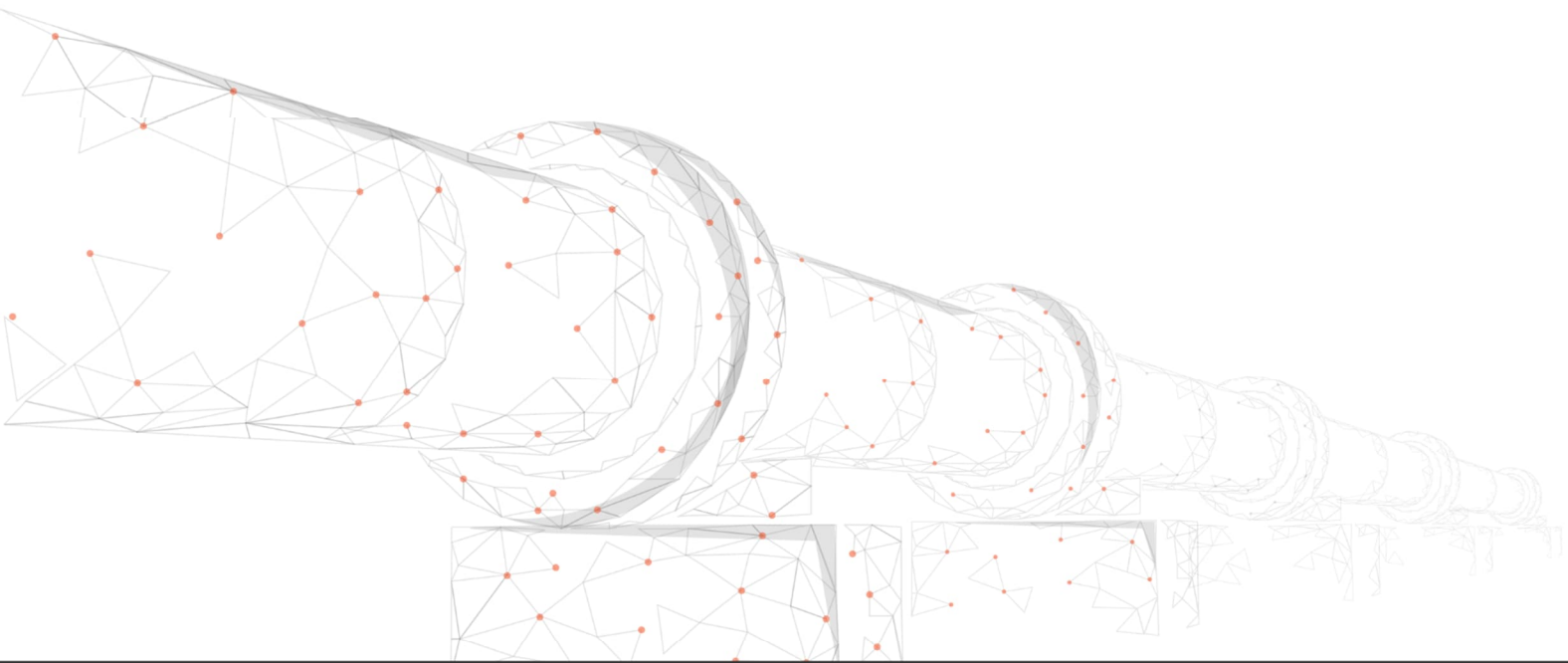

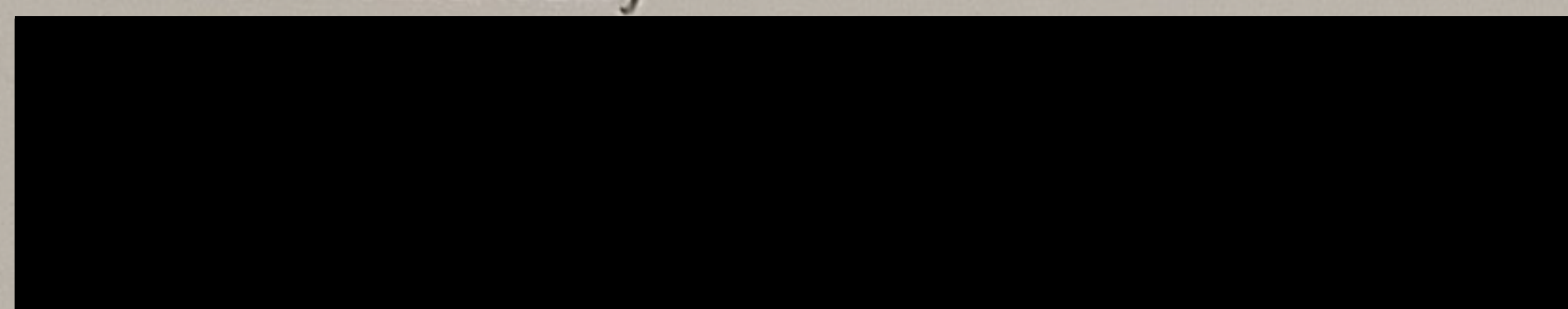
