

1. INTRODUCTION

1.1. OVERVIEW

1.1.1. This Other Consents and Licences document has been prepared on behalf of Liverpool Bay CCS Limited ('the Applicant') to support an application ('the Application') for a Development Consent Order ('DCO') that has been submitted to the Secretary of State ('SoS') for the Department for Energy Security and Net Zero (DESNZ) under Section 37 of the Planning Act 2008 (as amended) ('the PA 2008'). The Application relates to the CO₂ pipeline which constitutes the DCO Proposed Development.

1.2. PURPOSE OF THIS DOCUMENT

- 1.2.1. This document is prepared by WSP on behalf of the Applicant and provides a list of other consents, licences and permits that the Applicant may need to obtain to enable the construction, operation, maintenance and decommissioning of the DCO Proposed Development. These are *not* obtained as part of the DCO.
- 1.2.2. In accordance with Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the 'APFP Regulations'), this document is not a document required to accompany an application for Development Consent, however details of other consents, licences and permits are required to be detailed in the standard Application Form (D.1.4).[APP-004]).
- 1.2.3. The requirement to provide this information is additionally referred to within Paragraph 45 of the Department for Communities and Local Government Application Form Guidance (Department for Communities and Local Government, 2013).
- 1.2.4. This document may be updated and resubmitted during the examination to demonstrate progress made on obtaining any other necessary consents, licences or permits.
- 1.2.5. This document has been prepared in accordance with the guidance above to provide the outlined information.

2. OTHER CONSENTS, LICENCES AND PERMITS REQUIRED

- 2.1.1. Information on the other consents, licences and permits that are, or may be, required in connection with the construction, operation, maintenance or decommissioning of the DCO Proposed Development is set out in **Table 2.1** and **Table 2.2** below.
- 2.1.2. Decommissioning of the DCO Proposed Development is included within **Table** 2.1 and **Table 2.2** below, though these consents, licences and permits are not expected for some time in the future, by which time the permits required may be different or no longer needed.
- 2.1.3. **Table 2.1** is applied where other consents, licences and permits are required in England and Wales, whilst **Table 2.2** is applied where other consents, licences and permits are required in Wales only.
- 2.1.4. The document will be updated by the Applicant, as required, during the examination of the Application by the Examining Authority (ExA) on behalf of the Secretary of State (SoS).
