

Applicant's response to the ExA's Rule 17 letter, dated 14 September 2023

This document has been submitted at Deadline 9 in response to the request from the ExA (document reference: **D.7.67**).

Applicant's update on the Marine Licence

The Applicant resubmitted the Marine Licence application to Natural Resources Wales (NRW) on 5 September 2023 for the trenchless crossing works at the River Dee. NRW subsequently requested further clarification on the format of the coordinates. The Applicant provided NRW with the updated information on 15 September 2023 and NRW confirmed receipt on 18 September 2023. NRW has advised the Applicant that as part of the application process for the Marine Licence they are required to place an advert in a local newspaper or maritime publication that has a wide circulation in the area of where the works are to take place. The Applicant has received the wording for the public notice from NRW and will publish the notice at the earliest opportunity.

Statement of Progress on Statements of Common Ground

Table 1 below includes the stakeholders for which the Applicant has prepared and submitted a signed / unsigned SoCG at Deadline 9.

The updated Statement of Commonality (SoC) (document reference: **D.7.2**) submitted at Deadline 9 outlines the final position of all SoCGs that the Applicant has or has not entered into with relevant stakeholders/Interested Parties (IPs). Stakeholders/IPs in the last category have specifically stated they do not wish to enter into an SoCG with the Applicant. Further details on the status of all SoCG's are provided in Table 2-1 of the SoC.

The Applicant has attempted to enter good faith discussions during the pre-examination and examination periods with stakeholders/IPs and has provided evidence and updates to the ExA through the SoC and Cover Letters at each deadline on the progress of these discussions.
