1. INTRODUCTION

1.1. PURPOSE OF THIS DOCUMENT

- 1.1.1. This document has been prepared on behalf of Liverpool Bay CCS Limited ('the Applicant') and relates to an application ('the Application') for a Development Consent Order (DCO) that has been submitted to the Secretary of State (SoS) for Energy Security and Net Zero (DESNZ) (formerly BEIS) under Section 37 of the Planning Act 2008 ('the PA 2008'). The Application relates to the carbon dioxide (CO₂) pipeline which constitutes the DCO Proposed Development.
- 1.1.2. This document provides a schedule of the statutory undertakers, for whom their land rights and apparatus are within the order limits for the DCO Proposed Development.

1.2. THE DCO PROPOSED DEVELOPMENT

- 1.2.1. A full description of the DCO Proposed Development is detailed in Chapter 3 of the Environmental Statement (ES) [APP-055REP7-036].
- 1.2.2. At this time, the Applicant has not identified any statutory undertakers' apparatus which would require to be removed or diverted for the DCO Proposed Development to be carried out. Where utility or apparatus is required to diverted (for example because it is not in the location mapped), that would be covered by the protective provisions and a suitable alternative would be provided. The DCO Proposed Development would pass under infrastructure such as strategic highway and railways using trenchless techniques and with no impact on the use of the undertaking. The Applicant accordingly considers that there is no serious detriment to any statutory undertaking as a consequence of the proposal.
