<u>CHRYSAOR PRODUCTION (U.K.) LIMITED a Harbour Energy Company – Viking CCS pipeline (formerly V Net Zero pipeline) – Development Consent Order</u>

Introduction

We are writing following previous correspondence you would have received in relation to the Viking CCS pipeline, a new pipeline that will transport captured carbon dioxide from Immingham to the site of the former Theddlethorpe Gas Terminal. The carbon dioxide will then be transferred offshore through an existing pipeline and stored 9,000 feet beneath the seabed 120km off the Lincolnshire coast, as part of our Viking CCS CO2 Transport and Storage project (VCCS). Not only will the project put the region at the forefront of the UK's drive to achieve net zero but it will also support local economic growth.

The Viking CCS project supports a process known as 'carbon capture'. This involves capturing carbon at its point of emission, transporting it in a pipeline, and storing it deep underground, where it cannot escape into the atmosphere. This has the effect of reducing overall carbon emissions and will be crucial if the UK is to meet its target of being carbon net zero by 2050. As home to some of the largest carbon emitters in the UK, it makes economic and logistical sense for the Humber region to become a leader in carbon capture technology in the UK.

A corridor has been identified within which the proposed onshore 55km pipeline would be routed. You have been identified as having a land interest within this corridor and as such it is important that we ensure we have the correct information in relation to your land interest. Please be aware that not all of the route corridor will be required for the project.

Please be aware the with effect from 12 October 2022 V Net Zero, the carbon capture, transport and storage network led by Harbour Energy, has been renamed Viking CCS to better reflect the strength of its CO2 capture and storage capabilities, more information can be found on the relaunched website www.vikingccs.co.uk.

Land Referencing

Because of the national significance of the proposed Viking CCS pipeline, it requires a Development Consent Order (DCO) under the Planning Act 2008. The DCO application will be submitted to the Planning Inspectorate, who will then assess the application through the DCO examination process.

The DCO pre-application process includes public consultation, which allows stakeholders (including landowners, tenants, and others with an interest in land) to share their views on the project in advance of the application being made.

As part of this consultation, we have a legal requirement to carry out diligent inquiries to identify and consult all those potentially impacted by the project.





In October 2022, the V Net Zero pipeline changed its name to the Viking CCS pipeline to better reflect the strength of the project's carbon capture and storage capabilities. The project includes proposals to construct and operate a new 55km buried onshore pipeline that will transport captured CO_2 from Immingham to the former Theddlethorpe Gas Terminal (TGT). 

Welfare and pensions set to rise with inflation

Sunak preparing for £11bn pledge in budget

Rishi Sunak is expected to increase pensions and benefits in line with inflation in an effort to ensure the budget is seen as "fair and compassionate".

The Times has been told that assumptions sent to the official forecaster over the weekend included the two pledges, which would cost a combined £11 billion in 2023-24.

Final decisions have not been made but Sunak and Jeremy Hunt, his chancellor, are said to be instinctively opposed to breaking promises on pensions and benefits. This would mean deeper cuts in public spending elsewhere and bigger tax rises.

Of the financial plans, which will be announced on November 17, Sunak told The Times at the weekend: "You will rightly be able to judge, is that [the autumn budget] a fair approach, is that a compassionate approach? I'm confident that people will feel that it is but I don't want to pre-empt what the chancellor is going to say."

cellor is going to say."

Breaking the Tories' pledge to increase benefits in line with inflation would prompt a significant revolt from MPs. Several members of Sunak's cabinet, including Michael Gove, the levelling-up secretary, and Mel Stride, the work and pensions secretary, spoke out against doing so last month when they were on the back benches.

Tory MPs have raised concerns that increasing benefits in line with wages, rather than inflation, would see real-terms cuts in benefits for millions of people and warned against balancing the books "on the backs of the poorest".

The prime minister would also face a revolt if he attempted to break the triple lock, which increases state pensions in line with inflation or wages or by 2.5 per cent, depending on which is the highest. Inflation rose to 10.1 per cent in September.

Retaining the triple lock would cost the government about £6 billion next year, and increasing benefits in line with inflation would cost £5 billion. Both pledges were on a list of measures sent to the Office for Budget Responsibility, the fiscal watchdog, over the weekend as the prime minister and his chancellor draw up plans to cut £33 billion from public spending by 2027-28 while raising £21 billion from taxes.

There are likely to be big cuts to departmental budgets, apart from that of the NHS, and defence spending could be cut in real terms. Public sector workers are expected to receive belowinflation pay rises of 2 per cent

inflation pay rises of 2 per cent. Sunak and Hunt are also set to press ahead with several stealth taxes to help to balance the books

to balance the books.

The government is expected to freeze the "nil rate band" of inheritance tax — the rate at which people start paying the levy — for another two years until 2028, according to the Financial Times. The move is forecast to raise about £500 million.

Other plans include freezing income tax thresholds until 2027-28 so more workers are dragged into the higher rate of 40p. Sunak and Hunt are also likely to freeze the pensions lifetime allowance for two more years.

British will help French migrant patrols

Britain and France are in the "final stages" of agreeing a deal worth about £80 million that will lead to UK immigration officials being stationed in French control rooms for the first time.

The agreement is expected to pay for an increase in the 800 daily patrols that at present are carried out by French officers, as well as extra surveillance equipment to detect boats before they enter the water.

Rishi Sunak vowed to "grip this challenge of illegal migration" by "working with European partners" after he met a series of his EU counterparts at Cop27

in Egypt yesterday. After meeting President Macron for the first time as prime minister, Sunak said he had "renewed confidence and optimism" that co-operation between the two countries could stop the crossings.

The increase in beach patrols is not expected to include British officers from Border Force. The UK repeatedly has requested their involvement to help to prevent the crossings.
