And I'm going to take you through these now. Bear with me, because there's guite a few. So all of the action points that I've got noted are for the applicant. So that was taken a bit of speaking action point number one is to provide an update on discussions with Anglian Water, including the reasoning for the 200 metre width of corridor in the vicinity of their affected site. Action Point two is to strengthen the justification for the land take for compulsory acquisition from East Raven Dale farm. Action Point three is to expand on the relationship between onshore DCO infrastructure and offshore infrastructure and the consenting process. Use the net zero T side DCO to understand the issue and explain why the applicant has taken a different approach, including the potential use of requirements to prevent commencement of the onshore element until all consents are in place for the offshore element. action point four is to update in detail the planning statement to reflect the confirmed en one including paragraphs four point 9.19 and Auckland five 110. Action Point five is to update statement of reason for the change request to reflect the confirmed en one including paragraphs four point 9.19 and four point 5.10. Now on that one. All of the all of the timescale deadlines are to be submitted deadline one bearing in mind you've got this change request has been submitted, it might be in your interest to submit that as soon as you can. Action Point six is out updates the CEA tracker, including the number of objections to be done accurately. Action Points seven is to provide more information on company structure as described in the funding statement, including the relationships between the app current company and the parent company. action point eight is to confirm the name of the applicant of the offshore element. Action Point nine is to update costs for the overall project costs. Action Point 10 is to have endeavoured to make sure that the individual individual meetings that have taken place as landowners are included in the statement of negotiation. Action Point 11 is to provide detail on why the NGC MDT facility at federal Thorpe is not considered operational, including when did it ceased to be operational? And what are the MDT intentions for the site also includes an update on discussions with MGT. Action Point 12 is an update on the progress through the negotiations with the Crown Estate, including the lease for the logs pipeline. Finally, action point 13 is to provide the two option plans for the DVS a land at iminium.
