Rule 17 Letter

The Applicant notes the requests from the ExA in their Rule 17 letter dated 8th May and will arrange to submit the requested documentation at Deadline 3.

Accompanied Site Inspection

The Applicant has submitted in Annex A to this letter an updated schedule for the accompanied site inspection (ASI) to take place on 26 June. This takes account of (a) the comments of the ExA within Annex B of the Rule 8 letter on proposed locations and (b) that the ASI will be conducted in one day only.

The Applicant is making arrangements to access land for the ASI. Please note that it will not be possible for members of the public to access the Dune Valve, Theddlethorpe Gas Terminal and Immingham Facility as these sites have strict access requirements. Sensible sturdy footwear will be required for the ASI. Safety boots (with a steel toe cap) will be required for the Theddlethorpe Gas Terminal. The applicant will provide high visibility jackets for use during the ASI.
