Planning Act 2008. Application for Development Consent EN070008: Viking CCS Pipeline – Deadline 3 Submission.

Bentonite Breakout Management Plan

The applicant has prepared the Bentonite Breakout Management Plan for submission to the Examining Authority. The applicant is considering and addressing a number of points in the report which are classed as confidential. The report will be submitted to the Examining Authority as soon as possible.

Statements of Common Ground

Statements of Common Ground are being progressed with stakeholders with meetings and discussions having taken place. Where matters have been agreed within the Statements of Common Ground, updated documents have been submitted. Progress with each Statement of Common Ground is presented in the Statement of Commonality.

Rule 17 letter from the Examining Authority dated 24th May 2024

The applicant is submitting information requested in the letter dated 24th May 2024 including the Technical Note on Venting (EN070008/EXAM/9.35), Updated Transport Assessment (EN070008/APP/6.4.12.4) an updated Statement of Reasons (EN070008/APP/3.2) and further information regarding the construction programme (EN070008/EXAM/9.38).

Compulsory Acquisition Tracker

An updated Compulsory Acquisition Tracker (EN070008/APP/3.5) has been completed using the excel template provided by the Examining Authority in the Rule 17 letter dated 8th May 2024. This has been submitted in PDF and Excel format. The Applicant has sought to complete this so far as possible and include a level of detail that is of assistance to the Examining Authority. There were two points within this that the Applicant wished to note:

- One of the columns required the Applicant to list the "relevant interest", which allowed for a selection of 'part 1', 'part 2', or 'part 3'. The Applicant has completed this by reference to the relevant parts of the Book of Reference. Where some parties appear in multiple parts of the Book of Reference (e.g. where they are listed in part 1 as an owner and part 3 as having a category 3 interest), then the Applicant has selected 'part 1' from the drop down list.
- The Applicant has added in a column titled "Status of Negotiation" which provides a high level summary of negotiations between the Applicant and an interested party. Further detail is set out in the Schedule of Negotiations and Powers Sought (EN070008/APP/3.4).

Detail regarding Driver Vehicle Standards Agency (DVSA) routing options

The applicant is submitting document (EN070008/EXAM/9.34) showing the preferred route around the land owned and operated by the DVSA. The plan, including the preferred route, has been discussed and agreed in principle with the DVSA. A letter confirming their agreement is included with the plan. This information is submitted as requested by the examining authority in the rule 17 letter dated 8th May 2024.

Composite Draft Development Consent Order

The Applicant has been unable to produce a version of the draft DCO for Deadline 3 showing a composite of all changes, colour coded for each version that has been submitted. This is due to difficulties with the formatting of the document within the Statutory Instrument template. However, the Applicant is working to resolve the formatting issue and will submit a Composite draft DCO as soon as possible.
