Purpose of ISH

The main purpose of the ISH2 is to clarify and get views on strategic matters relating to:

1. The scope of the Proposed Development;
2. The function of specific Articles and Requirements; and
3. Any outstanding points of dispute on the content of the DCO.

These matters may also be covered in some detail in the Examining Authority's Second Written Questions that will be published on 12 August 2024. At ISH2, we are looking for clarity on the Applicant's strategic approach on the matters listed here and Interested Parties' views on that approach.

Procedure at ISH

Guidance under the Planning Act 2008 and the Infrastructure Planning (Examination Procedure) Rules 2010 provides that it is for the ExA to probe, test and assess the evidence through direct questions of persons making oral representations at Hearings. Questioning at the Hearing will be led by the ExA. Cross questioning of a person giving evidence by another person will only be permitted if the ExA decides it is necessary to ensure representations are adequately tested or that an IP has had a fair chance to put its case.
