# MOD Safeguarding – Donna Nook Air Weapon Range

**Proposal**: AECOM are working for Chrysaor Production (UK) Ltd ("the Applicant") on their application for a Development Consent Order (DCO) for the Viking CCS Pipeline Project ("the Proposed Development"). An application for development consent was submitted on 23 October 2023, and the application was accepted by the Planning Inspectorate for examination on 17 November 2023. The Examination commenced on 26 March 2024 and the Examining Authority issued their first round of Written Questions on 3 April 2024. The Examining Authority has asked the Applicant to respond to the following question: 1.9.1: The Defence Infrastructure Organisation] have highlighted the proximity of the Proposed Development to the Donna Nook Air Weapon Range. Set out clearly the Applicant's position into the likely environmental effects upon this installation and what, if any, specific mitigation is required to ensure the compatibility of the Proposed Development with the existing use.

Location: From Immingham to the former Theddlethorpe Gas Terminal (TGT).

Thank you for consulting Defence Infrastructure Organisation (DIO) on the above proposed development which was received by this office on the 17/04/2024.

The Defence Infrastructure Organisation (DIO) Safeguarding Team represents the Ministry of Defence (MOD) as a consultee in UK planning and energy consenting systems to ensure that development does not compromise or degrade the operation of defence sites such as aerodromes, explosives storage sites, air weapon ranges, and technical sites or training resources such as the UK Military Low Flying System.

AECOM, on behalf of the applicant, have enquired if any specific mitigation is required to ensure the compatibility of the proposed development with the Air Weapon Range at RAF Donna Nook in relation to a proposed Pipeline project, comprising a new 55 km (approx.) onshore underground pipeline that will transport captured CO2.

The application route occupies the range statutory safeguarding zone surrounding RAF Donna Nook with the closest point of the range lying 1.8km away.

## Low Flying

In this case the development falls within Low Flying Area 11 (LFA 11), an area within which military aircraft may conduct low level flight training. The addition of a development

featuring tall or narrow profile structures such as masts or vent flue stacks in this locality has the potential to introduce a physical obstruction to low flying aircraft operating in the area.

In summary the MOD has no objection to this application for a Development Consent Order, subject to any vent stacks being charted on aviation maps. MOD requirements are set out in Appendix A.

The MOD must emphasise that the response provided to this enquiry is provided specifically in response to the application documents and supporting information dated 17 November 2023, within the examination stage review of the application and is response to the written questions on 3 April 2024.

Any variation of the parameters (which include the location, dimensions, form, and finishing materials) detailed may significantly alter how the development relates to MOD safeguarding requirements and cause adverse impacts to safeguarded defence assets or capabilities. In the event that any amendment, whether considered material or not by the determining authority, is submitted for approval, the MOD should be consulted and provided with adequate time to carry out assessments and provide a formal response.
