1 Introduction

1.1 Overview

1.1.1 This Statement of Common Ground (SoCG) has been prepared by Chrysaor Production (UK) Ltd (the 'Applicant') in conjunction with Anglian Water in respect of the Viking CCS Pipeline project (the 'Proposed Development').

1.1.2 The SoCG sets out the matters of agreement between the Applicant and Anglian Water and also explains those matters which, at the time of writing, remain unresolved between the parties. The agreements to date have been reached through consultation and continuing discussions between the parties through online meetings.

1.2 The Role of Anglian Water

1.2.1 Anglian Water Services Limited ("Anglian Water") is appointed as the water and sewerage undertaker for the Anglian region, by virtue of an appointment made under the Water Industry Act ("WIA") 1991. Anglian Water is a wholly owned subsidiary of AWG Plc. The principal duties of a water and sewerage undertaker are set out in the WIA.

1.2.2 Anglian Water is a statutory consultee for the proposed Viking CCS pipeline under Section 42 of the Planning Act (2008).

1.2.3 Anglian Water is supportive in principle of the Viking CCS project given that it provides a method to transfer and store the United Kingdoms' greenhouse gas (GHG) emissions which are contributing to climate change. One of Anglian Water's five environmental objectives is to mitigate climate change through reducing GHG emissions in both operations and as part of construction and maintenance projects. Anglian Water, in working with Nationally Significant Infrastructure Projects (NSIP) seeks to minimise the need for works to divert existing assets and to provide new water and wastewater connections which themselves have attendant capital carbon and potentially operational carbon emissions.

1.3 Purpose of this Statement of Common Ground

1.3.1 The purpose of this document is to summarise the agreements reached between the parties on matters relevant to the examination of the application and to assist the Examining Authority ('ExA'). It also sets out the matters that remain unresolved at the time of writing, but which both parties are working positively toward resolving. As such, it is expected that further iterations of the SoCG will be submitted to the ExA throughout the Examination and prior to the making of any Development Consent Order ('DCO') for the Proposed Development.

1.3.2 The SoCG has been prepared with regard to the guidance in 'Planning Act 2008: examination of applications for development consent' (Department for Communities and Local Government, March 2015).

1.3.3 The remainder of this SoCG is structured as follows:

2 Summary of Consultation and Discussions

Introduction

2.1.1 In addition to the consultation undertaken as part of statutory consultation, there have been a number of meetings and correspondence relating to the Proposed Development. 3 Position of the Parties

3.1.1 Table 3-1 sets out the position of the parties relating to the following topics:

- Pipeline routeing across land east of Anglian Water Recycling Centre at Louth
- General protective provisions for other Anglian Water assets such as water pipelines.

3.1.2 To provide clarity, each of the matters for which a position has been attributed have been colour coded as follows:

Agreed	The matter is agreed between the parties, or there are no significant disagreement such that the matter is considered closed.
Not Agreed but not material	The matter is not agreed between the parties; however the outcome of the approach taken by the Applicant or Anglian Water is not considered to result in a material impact to the assessment conclusions. Discussions on this matter have concluded.
In Discussion	This matter is neither 'agreed' or 'not agreed'. Technical work is being undertaken with the aim of achieving agreement, though the risk of disagreement remains.
Not Agreed	The matter is not agreed between the parties and the outcome of the approach taken by the Applicant or Anglian Water is considered to result in a materially different impact to the assessment conclusions.
