# 1 Introduction

## 1.1 Purpose of this Document

- 1.1.1 This Statement of Commonality has been prepared to provide the Examining Authority (ExA) with a summary of the current position and progress towards preparing and agreeing Statements of Common Ground (SoCG) between Chrysaor Production (UK) Limited (“the Applicant”) and relevant statutory consultees, statutory undertakers and interested parties (“other parties”) in relation to the proposed Viking CCS Pipeline (the “DCO Proposed Development”).
- 1.1.2 The Rule 6 Letter dated 15 February 2024 requires the submission of SoCGs requested by the ExA and a Statement of Commonality for SoCGs at Deadline 1 with further updates if required, as per the Rule 8 letter at each subsequent deadlines (Deadline 3, 4, and 5) up to the submission of finalised SoCGs at Deadline 6 on 19th September. The Examining Authority requested in the –Rule 17 letter dated 20<sup>th</sup> September 2024 final versions of unsubmitted Statements of Common Ground be submitted at Deadline 7.
- 1.1.3 This document provides the final position on the commonality on specific points in the SoCGs at Examination Deadline 76 (26<sup>th</sup>19<sup>nd</sup> September 2024). ~~This document was updated for Examination Deadline 6 where the final Statements of Common Ground have been submitted.~~

## 2 List of Statements of Common Ground

### 2.1 List of SoCGs

- 2.1.1 In accordance with the guidance published by the Department for Communities and Local Government<sup>1</sup> (DCLG), the Applicant has prepared SoCGs with a number of statutory consultees, statutory undertakers and interested parties during the preparation of the DCO and during the Examination stage.
- 2.1.2 The SoCGs identify matters on which parties agree and document the position of each party where agreement has not been reached. Table 2-1 below provides a list of SoCGs that have been ~~are being~~ prepared and their ~~current~~ status.
- 2.1.3 The applicant has updated and exchanged ~~Statements of Common Ground SoCG~~ with Interested Parties several times during the Examination period. While the applicant has endeavoured to finalise all ~~Statements of Common Ground SoCG~~ for Deadline 6 and 7 it has not been possible to obtain the final signatures for all documents. # 4 Commonality

## 4.1 Summary

- 4.1.1 This section of the document provides a summary of issues covered in the SoCGs and demonstrates where there is commonality in the topics or matters being discussed with the various parties. The summary in Table 4-1 relates to those SoCGs being progressed, as summarised in Section 3.
- 4.1.2 The table presents topics covered within the various SoCGs and shows how these are relevant to each party and a position for each topic as follows:

<b>Agreed</b>	The matter is agreed between the parties, or there is no significant disagreement such that the matter is considered closed.
<b>Not Agreed – No material Impact</b>	The matter is not agreed between the parties; however the outcome of the approach taken by the Applicant or East Lindsey District Council is not considered to result in a material impact to the assessment conclusions. Discussions on this matter have concluded.
<b>In Discussion</b>	This matter is neither ‘agreed’ or ‘not agreed’. Technical work is being undertaken with the aim of achieving agreement, though the risk of disagreement remains.
