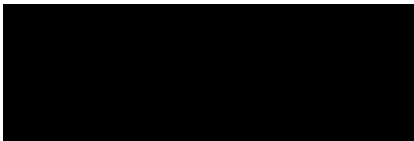
In addition, Navigator will attend any ASI's and would request that the following locations are included:
