1.0 H2TEESSIDE ACCOMPANIED SITE INSPECTION 1 ITINERARY – 12TH NOVEMBER 2024

1.1 ASI Itinerary

- 1.1.1 This Draft Accompanied Site Inspection 1 ('ASI1') Itinerary has been developed on the basis of the Applicant's experience of what is feasible to visit in a single day. The Applicant has noted the comments made by the Interested Parties at Deadlines 1 and 2 in respect of the itinerary for ASI1. The updated ASI1 Itinerary includes the additional location suggestions as far as logistically possible but considers that it is not possible to visit all the suggested locations in a single day and therefore suggests any outstanding locations are included in any subsequent ASI the Examining Authority ('ExA') considers it appropriate to schedule. The locations not included in the itinerary for AS1 are as follows:
 - **CF Fertilisers UK Limited** suggest that their main site is included. This is not logistically possible to cover in one day. It is suggested that this is covered in a subsequent ASI if the ExA considers that appropriate.
 - Navigator Terminals Limited suggest that elements of the link line corridor where it exits the tunnel under the river as included. This is not logistically possible to cover in one day. It is suggested that this is covered in a subsequent ASI if the ExA considers that appropriate.
 - Sembcorp Utilities (UK) Limited the Wilton Estate should be included. Parts of the Wilton Estate are planned to be covered in ASI1 but not its entirety. It is not logistically possible to cover the entire Wilton Estate in one day. It is suggested that this is covered in a subsequent ASI if the ExA considers that appropriate.
- 1.1.2 The timetable below is based on an earlier start time of 08:00 in view of the more limited daylight hours in November (sunset will be around 16.07) with a meeting point at the Wilton Centre Car Park (TS10 4RF). The locations listed in **Table 1.1** below are shown indicatively on **Figure 1.1** at the end of this document.

1.2 Notes on Itinerary
