1.0 INTRODUCTION

1.1 Overview

- 1.1.1 This document has been prepared on behalf of H2Teesside Limited (the 'Applicant'). It relates to an application (the 'Application') for a Development consent Order (a 'DCO'), that was submitted to the Secretary of State for Energy Security and Net Zero ('DESNZ') on 25 March 2024, under Section 37 of the Planning Act 2008 (the 'PA 2008') in respect of the H2Teesside Project (the 'Proposed Development').
- 1.1.2 The Application has been accepted for examination. The Examination commenced on 29 August 2024.

1.2 The Purpose and Structure of this document

1.2.1 The original response to Q1.6.44 is contained in '8.11.6 Response to ExQ1 Compulsory Acquisition and Temporary Possession' submitted at Deadline 2 [REP2-024]. The purpose of this document is to provide the Applicant's follow up response to the Examining Authority's First Written Question 1.6.44 ('Q1.6.44').

1.3 Supplementary response to ExQ1 1.6.44

- 1.3.1 Paragraphs 9.1.64-9.1.70 of the Statement of Reasons [APP-024] outline how the SoS can be satisfied that the tests outlined in sections 127(3) and (6) and 138(4) of the Planning Act 2008 are met. In summary, Article 34 of the dDCO [REP2-004] provides the undertaker with certain powers in relation to compulsory acquisition and acquisition of rights of statutory undertakers within the Order Land. However, these powers are subject to the provisions in Schedules 16-22 of the dDCO [REP2-004]. Relevantly:
- 1.3.1.1 Schedule 16 provides protective provisions for the protection of electricity, gas, water and sewerage undertakers and therefore benefit Northern Gas Networks Limited and Northern Powergrid (Northeast) PLC, and any other statutory undertakers within those categories who may have apparatus within the Order Land.
- 1.3.1.2 Schedule 17 provides protective provisions for the protection of operators of electronic communications code network and therefore benefit Openreach Limited, On Tower UK 5 Limited, Virgin Media Limited and Vodafone Limited.
- 1.3.1.3 Schedules 19 and 20 provide protective provisions specifically for National Grid Electricity Transmission PLC and National Gas Transmission PLC respectively.
- 1.3.1.4 Schedule 21 provides protective provisions for the protection of railway interests, which will benefit Network Rail Infrastructure Limited.
- 1.3.2 The Applicant is in discussions with statutory undertakers regarding the appropriate terms of these protective provisions. Notwithstanding those continued discussions the Applicant considers that the protective provisions included within the draft DCO [REP2-004] are adequate and appropriate, and ensure that the tests in sections 127 and 138 noted above are met.



- 1.3.3 The provisions in Schedules 16-17 and 19-21 satisfy the requirements outlined in sections 127(3) and (6) and 138(4) of the Planning Act 2008. For example, paragraph 5 of Schedule 16 to the draft DCO [REP2-004] prohibits the Applicant from acquiring apparatus other than by agreement. Paragraph 6 requires replacement apparatus and access to that replacement apparatus to be in place before the Applicant acquires an interest in land in which the undertaker's apparatus is placed or over which access to any apparatus is enjoyed, or requires that the utility undertaker's apparatus is relocated or diverted. Paragraph 8 requires the utility undertaker to approve any works on or under any land purchased, held, appropriated or used that are near to, or will or may affect, any of the statutory undertaker's apparatus. These provisions, and similar ones in the other schedules noted, ensure that the statutory undertakings of the relevant entities will be appropriately preserved or protected.
- 1.3.4 Section 127 Planning Act 2008 is satisfied where the SoS is satisfied that the statutory undertaker's land or right over land can be purchased or replaced without serious detriment to the carrying on of the undertaking. Some statutory undertakers have asserted that the Proposed Development will cause serious detriment to the carrying on of their undertaking. However, the need for any particular apparatus to be relocated or diverted depends on the detailed design of the Proposed Development. At this stage of the design the need for any particular relocation or diversion of apparatus is not known. The important point though is not whether re-location or diversion will occur, but that the draft DCO as a whole, including in particular the protective provisions, will ensure that the statutory undertakers will not suffer serious detriment.
- 1.3.5 Table 1-1 on the following page of this document sets out the works taking place in the land of, or potentially affecting apparatus of, the statutory undertakers listed in the response to ExQ1 1.6.44. The original response to ExQ1 1.6.44 is contained in '8.11.6 Response to ExQ1 Compulsory Acquisition and Temporary Possession' submitted at Deadline 2 [REP2-024].
