As you are aware my colleague Kamran Hyder and I had registered to speak on behalf of NWL at the forthcoming hearings scheduled to take place on Wednesday and Thursday this week, attending via MS Teams.

You will be aware from our correspondence dated 3 October and 21 October 2024 of our client's position in this matter. That position has not changed although I am pleased to report that our client is engaged in discussions with the promoter in relation to the nature and scope of the necessary protective provisions and the availability of raw water associated with the proposal.

Given that we have yet to finalise our instructions in relation to the protective provisions, we do not envisage being able to usefully assist the Examiner at the hearings this week, and as such I am emailing to notify you that we no longer intend to attend or speak at either hearing to be held this week.
