Dear H2 Team

For the attention of the Examining Authority (ExA)

Issue Specific Hearings (ISH)

With regards to the hearing on 14th January 2025, we will not be attending but would be pleased to respond to any questions from the ExA that arise from the hearing at a subsequent deadline.

We are unable to attend as we await further information on a number of issues from the Applicant that may impact our oral advice to the ExA. These issues include SPA birds (noise and visual disturbance, impacts on functionally linked land and in combination assessment), air quality impacts/ mitigation with regards to Teesmouth & Cleveland Coast SSSI/ SPA and details of the closed loop system with regards to amines (air and water quality).

We have been engaging regularly with the Applicant on these issues and have made progress in relation to the bird impacts assessment methodology. However, we are yet to receive the final assessment. The Applicant did state (during meeting between NE and AECOM on 11/12/24) that they will send this and a technical note on bird disturbance to us to review but we have not received this so far. This information is required in order for us to give further advice to the ExA.

With regards to air quality mitigation, we provided an email update to the Applicant on 11/12/24 where we outlined our preferred approach for air quality mitigation and further requested details of the closed loop system. We are yet to receive an update on how this advice has been taken forward.

Until we have this further information, we are unable to advise on whether the further work being undertaken by the Applicant meets our concerns raised in our Relevant and Written Representations on these matters. Should the ExA wish to hear from Natural England in person we would be willing to attend a further hearing once we have the outstanding information.

To provide assistance to you for the Environment Item Specific Hearing on 14/01/25 we will send you an update on the issues you wish to discuss specific to Natural England's remit and representations. We will send you this by 08/01/25.

We would like to highlight that where Natural England does not attend hearings, this should not be construed as a lack of concern on outstanding issues. We remain concerned in particular at the potential impacts arising from noise/ visual disturbance and loss of functionally linked land on SPA birds, both alone and in-combination with other projects, disturbance impacts on seals and air quality impacts on Teesmouth & Cleveland Coast SSSI/ SPA and look forward to further information from the applicant to address this.
