Feedback on the Programme Document	The applicant supplied the Inspectorate with its initial Programme Document in line with the Expression of Interest process after the publication of the 2024 Pre-application Prospectus. Having reviewed the document, the Inspectorate considers that it is mostly satisfactory and covers the expected content as set out in the government's pre- application guidance at paragraph 10, namely:	
	 the date the applicant intends to submit their application 	
	 a comprehensive timetable of the applicant's pre- application process, the main events with dates and milestones demonstrating how the pre-application process will be completed (using the maximum target of 2 years as a benchmark) 	
	 the applicant's view on the main issues for resolution and activities they will undertake to address those 	
	 the applicant's proposals for engaging with statutory consultees and local authorities during the pre- application period and any intended financial support agreements, such as Planning Performance Agreements (PPAs) 	
	• the applicant's identification of risks to achievement of the pre-application stage and the process by which these risks are tracked and managed	
	The Programme Document provides enough detail about the proposed development, timetable and activities for the pre- application process at this stage. However, in the next iteration, the applicant will need to cross references to the SoCC required by <u>section 47 of the Planning Act</u> , which is a requirement of the Programme Document as outlined in the Pre-application Prospectus. It would also be helpful if the applicant includes the timescale for the Adequacy of Consultation Milestone.
