Thank you for your e-mail and enlightening response to my question about the proposed height of the new A556 travelling across the area of land adjacent to Chapel Lane.

The two answers are comprehensible given the implied restriction of the multi-product pipeline and drainage system level. This however is surely a resolvable restriction?

Moreover, given the willingness, the problem as describe can be overcome by design and a greater financial commitment to lowering the road plan to ground level.

Great strides have been made in reducing the impact of the bridge height over Chapel Lane and to complete the picture why not reduce the level of the new A556?

If the existing proposal is taken forward as it stands, it will be very difficult to rectify or amend in the future. Therefore, in this important case cost should not surely be a restriction.

I trust you and the planners will be good enough to discuss and reconsider the subject more deeply either by representation or other available method with the object of lowering the height plan for the new road.

I hope you will find this comment helpful as intended.

Dear Mr Whittle

Thank you for your e-mail.

The alignment of the new A556 has been lowered where possible, but, as our e-mails below point out, this has not been possible around Chapel Lane. The road will be about 1 metre above existing ground levels.

There are two main reasons for the designed level of the carriageway in the Chapel Lane area. These are:

- 1. An interaction withan existing multi-product pipeline, which is a constraint on lowering the alignment. If we lowered the alignment to or below ground level, we would be likely to need a much more extensive diversion of this pipeline.
- 2. Our need to ensure that the new scheme drainage system can remain gravity fed, which means we can avoid the need to introduce a pumped drainage system; this would have cost and long-term maintenance and operation implications.

I hope that this e-mail answers your query.
