Your enquiry has sparked the realisation that we did not send the letter to Breckland District Council. This was an unfortunate human error, but not one which has caused us to fall foul of legislation as the letter is for guidance only. While the request for the LIR was sent (as part of the 6 June 2014 letter to all interested parties), the authority decided not to provide a report. This is not uncommon for neighbouring authorities. The Planning Inspectorate's letter requesting the submission of Local Impact Reports (LIR), was issued to all interested parties on the 6 June 2014, this is known as the 'Notice of procedural decisions made following the Preliminary Meeting' letter and can be viewed here:

During the pre-application stage, prior to submission of the application to the Planning Inspectorate, we issued what is known as an 'information about a proposed application' letter to the host and neighbouring authorities.
